The testimony deals with UH Mānoa claiming to be an Aloha ‘Āina university in their last accreditation and in general advertisements. These are the points that were brought up: UH cannot be an Aloha ‘Āina university while supporting the TMT, UH only exists because it sits on 100% stolen Hawaiian land but doesn’t give free tuition for all Hawaiian students, the need for a public forum trying to co-opt Aloha ‘Āina for the call for the liberation of Kanaka Maoli, want for Kaleikoa Kaeo, a UH Mānoa PhD education student, to speak on Aloha ‘Āina’s behalf.

OPEN FORUM

President Kim Regarding the testimony, would anyone like to share their thoughts or opinions?

Senator Hokama-Paris On behalf of myself and Hawai‘inuiākea as I am the senator, many of us at the university and Native Hawaiians feel the same way as Punia as written here. In light of this testimony, I would like to entertain this conversation in terms of what ASUH stands behind. Do we support this Aloha ‘Āina? For Hawaiians, Aloha ‘Āina is a lifestyle and not something that is just a 9-5 or the university can just take and make money off of people. Aloha ‘Āina is something that we live by, it is something that we as Kānaka Maoli body, in terms of us welcoming the various students on campus. I support this testimony 100% but I’m curious about you all. Do you folks, as senators for your particular college and school, do you feel the need to support this testimony

and from there we can gauge what ASUH stands for because we are a collective body of voices.

Vice-President Renteria

Usually when we get testimony, it's something that we're already working on. My question is what was this testimony specifically in response to and is there anything that we hope to request from ASUH?

President Kim

According to Robert's Rules, they would not be able to respond casually. They're allowed 300 seconds of testimony unless we directly call them. Is that right, Advisor Sonoda-Pale? Can we ask the person who provided the testimony questions in an open forum or not?

Advisor Sonoda-Pale

I believe so but you are right in terms of Robert's Rules where we don't interact but it is an open forum.

President Kim

Puni, would you like to answer Vice-President Renterias questions regarding what specific actions you are requesting from ASUH?

Punia Pale

I just want you guys to push the administration to respond to Kaleikoa who has been asking for an open forum to speak on this topic.

President Kim

For context, this has been a conversation that has been going on for a while. From what I have seen, it has been more widely discussed, especially because of the last accreditation. I believe [past officers] President Li, Vice-President Simeona, and President Albano have also commented on the use of Aloha 'Āina in UH Mānoa's accreditation during their terms so it isn't something that we haven't seen before. It is definitely feasible for us to pursue this

Senator Mihailuk

I personally have not talked to the students within the school I represent but I feel that Aloha 'Āina is poorly misused within this context. I also believe that you cannot be an Aloha 'Āina university while supporting TMT, it is paradoxing and a gross one at that. I would be open to supporting a forum with administration, students, kumu's, and Kanaka on the use of the term.

President Kim

What will be the goal of the public forum and this question goes to all the senators, how can we bring this vision to life.

Punia Pale

The best goal of the public forum is UH acknowledging that they are built on stolen Hawaiian land and a discussion of justice, not only Aloha 'Āina in that sense regarding the stolen lands. I feel like a lot of things can play out. I feel like that is the first step on a long road of this public discussion.

Senator Hokama-Paris

I personally would like to see ASUH come out with an official statement regarding Punia's statement, he is a student and he has voiced concern, the first student in months, if I might add. That in itself is a testimony to his willingness to stay firm and true to his Kanaka and for his efforts to bring this to light for administration and our day to day lives. I know that Advisor Sonoda-Pale shared with both President Kim and I a chain between Kaleikoa, Kaeo, Dean of Hawai'inuiākea, Dean John, as well as President Lassner. If any of you folks want to get up to date with this chain and do the readings and research necessary to back this, feel free to reach out to me or President Kim. Going back and reading the words of President Lassner and Dean

John, there is a lack of Aloha ‘Āina in their replies, and their replies to Kaleikoa say enough, in my opinion. How would ASUH come out with an official statement backing and supporting this testimony and its beliefs of what it means to have Aloha ‘Āina.

President Kim

Typically, a resolution would be needed. I don't think we have a resolution that is specifically toward this topic and if we don't, we should definitely do the research and go into the past resolutions and write a resolution that calls on those needed to achieve this goal. Unfortunately, we can't come to a consensus and pass a senate wide agreement on a stance that we hold, as a resolution is the only official way of doing that. I will send an email to everybody including Punia so that we can discuss this and pursue your goals.

Vice-President Renteria

I think the easiest way to move this situation forward is to make an ad-hoc committee to make a resolution and work on creating a public forum for this to happen. I know we've held forums in the past. I think the last one was for the textbooks, how we wanted to be more accessible. The last time we passed legislation besides the Aloha ‘Āina bill was a resolution about how ASUH is opposed to TMT.

President Kim

I will send an email out to get everything rolling and establish an ad-hoc committee for this specific topic, if that is what the Senate is pursuing or if enough senators are invested and want to pursue this.
