**SENATE ACT 09-22:**  
**TO APPROPRIATE FUNDING FOR SOCIETY OF WOMEN ENGINEERS’**  
**FALL 2021 RIO FUNDING EVENT**

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

SECTION I. PURPOSE

To appropriate funding for the Fall 2021 RIO Funding Cycle. The eligibility process includes attending a mandatory orientation, an interview with the Finance Committee, and submitting required forms as well as presenting an itemized budget. ASUH does not require RIOs to have completed their registration to apply and receive funding. However, registration must be complete in order to claim awards. All RIOs receiving funding have met all deadlines and requirements.

SECTION II. APPROPRIATIONS

A total of \$1,300.00 shall be appropriated from Senate Account #3325242 (RIO Funding Account).

SECTION III. PROVISIONS

ASUH shall be recognized as co-funding this event at said event and on all advertising with the phrase “partially funded by ASUH.” Partial funding of said event shall not constitute co-sponsorship by ASUH. ASUH neither implies nor accepts any liability as a result of partially funding said event.

ASUH shall be recognized as a sponsor/co-sponsor of this event/project.

All RIO’s are required to use their funding for the benefit of undergraduates at the University of Hawai‘i at Mānoa.

Due to the ongoing pandemic, the past community service requirement has been temporarily modified to follow state guidelines. Community service is not required this funding cycle.

All funded events must comply with state and federal guidelines relating to the COVID-19 pandemic.

SECTION IV. Any unexpended and unencumbered balance of any appropriation of this Act, as of the close of business on May 4, 2021, shall lapse into Senate Account #3325232.
