SENATE ACT 29-17

TO APPROPRIATE FUNDING FOR “A STUDENT A-FAIR: WE WORK BETTER TOGETHER” EVENT

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

SECTION I. PURPOSE

"A student a-FAIR: we work better together" is an event being organized by the PAU Violence Program Prevention Advisory Committee. This event is scheduled for Wednesday, April 5, 2017 from 1:00 pm - 4:00 pm in the Campus Center courtyard and will bring together various campus and community programs that support students. The primary goals of this event are to build a sense of community at UH Mānoa around the common theme of improving student wellness, promote community engagement by providing a “one stop shop” for student programs and services, and celebrate diversity and inclusion through the collaboration of campus and community programs working in all areas of student life.

Representatives from the Office of the Vice Chancellor for Students, Department of Public Safety, Office of Title IX, Office of Gender Equity, Student Housing Services, LGBT Student Services, Athletics Department, Office of Judicial Affairs, and University Health Services Health Promotion Program will be onsite at the event to meet with students, answer questions, and advertise the resources and services available to assist student success.

SECTION II. APPROPRIATIONS

A total of \$1200.00 shall be appropriated from Senate Account 3325232 (University Programs, Services and Support).

SECTION IV. Any unexpended and unencumbered balance of any appropriation of this Act, as of the close of business on May 3, 2017, shall lapse into Senate Account 3325232.

SECTION V. The Treasurer is authorized to draw upon said account.

SECTION IV. This Act shall take effect upon approval by the Senate.
