**FUNDING FOR THE STUDENT PARENTS AT MĀNOA SP@M HEALTH & WELLNESS
OHANA FAIR**

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

SECTION I. PURPOSE

The purpose of the Student Parents at Mānoa (SP@M) Health & Wellness Ohana Resource Fair: Celebrating Our Campus Diversity is to assist our diverse UHM student population emphasizing our student parents and adult learners with campus and community resources to help them succeed in their educational goals. The SP@M program acts as an important resource center providing information about childcare and community social services, in addition to referring students to UHM student support programs. The SP@M program advocates for pregnant students, parenting students and student parents of children with special needs, and supports the expansion of student parent-friendly lactation spaces and family friendly policies and spaces on campus. At this event, SP@M will continue a partnership with Helping Hands Hawai'i to promote the Supplemental Nutrition Assistance Program (SNAP), while providing enrollment services. The date for the 3rd Annual Health & Wellness Ohana Resource Fair is Thursday, November 1, 2018 from 10:30 am – 2:00 pm and will be held at the UHM Campus Center Courtyard.

This act shall take effect upon approval by the Senate, pending on the approval of the ASUH Budget by all required signatories.

SECTION II. APPROPRIATIONS

A total of \$3,730.00 shall be appropriated from Senate Account #3325232 (University Programs, Services and Support).

SECTION III. PROVISIONS

In accordance to the ASUH Senate Rule 27-1(h), the non-ASUH organization that may be funded is required to submit a follow up report on the proposed event or program. The

follow up report shall include information regarding finances if any appropriations had been made in this measure to said organization.

ASUH shall be recognized as co-funding this event at said event and on all advertising with the phrase “partially funded by ASUH.” Partial funding of said event shall not constitute co-sponsorship by ASUH. ASUH neither implies nor accepts any liability as a result of partially funding said event.

ASUH shall be recognized as a co-sponsor of this event/project

SECTION IV. Any unexpended and unencumbered balance of any appropriation of this Act, as of the close of business on May 1, 2019 shall lapse into Senate Account #3325232.

SECTION V. The Treasurer is authorized to draw upon said account.

SECTION IV. This act shall take effect upon approval by the Senate.
