**SENATE ACT 17-18**

**To Appropriate Funding for an ASUH & GSO Fall 2017 Town Hall Event**

**BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:**

**SECTION I    PURPOSE**

The ASUH and GSO will be hosting its first Town Hall Event this year to provide an avenue for students to 1) learn about University Resources that correlate to areas of student interest and concern, 2) to meet and have conversations with relevant university and community entities and administration, and 3) be able to direct general student concerns and ideas to both student government organizations to strengthen the student voice and guide ASUH and GSO to advocate collaboratively. The student attendance and participation at this event will also help ASUH and GSO improve its engagement with its constituents, and better gauge the student perspective to guide ASUH and GSO’s advocacy efforts. The Town Hall “theme” this semester is “Research” and will take place on November 13, 2017 5:30 pm - 7 pm.

This year, the ASUH & GSO is working on unifying and strengthening the student voice. Efforts such as hosting this event are directly related to that. For this event, ASUH will be working on advertising (graphics) and provide funding for refreshments. GSO will also help advertise the event, and has rented out the venue and necessary equipment. Both ASUH and GSO will be working on ways to collect student concerns at the event.
