SENATE ACT 15-16

TO APPROPRIATE FUNDING FOR STUDENT PARENTS AT MANOA NON-TRADITIONAL STUDENT CELEBRATION

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

SECTION I. PURPOSE

The purpose of the Student Parents at Manoa (SPAM) Non-Traditional Student Celebration is to assist student parents with campus and community resources to help them succeed in their educational goals. The SPAM program acts as an important resource center providing information about childcare and social services. The SPAM program advocates for pregnant students, student parents of children with special needs, and supports the expansion of student-friendly lactation spaces on campus. At this event, SPAM will continue a partnership with Helping Hands Hawaii to promote the Supplemental Nutrition Assistance Program (SNAP). The SNAP campaign is for all qualifying low-income students with supplemental needs.

During National Non-Traditional Student Week (November 2-6), SPAM will be partnering with the Office of Veteran Support Services (OVSS) to represent the diversity of our campus community. The SPAM program is run by the Women's Center on campus. Student Parents at Manoa is requesting financial funding for the Non-Traditional Student Celebration to promote both the SPAM program and the Office of Veteran Support Services (OVSS); to advertise the event; to provide food, prizes and entertainment; and for tent rental. The date for the 3rd Annual Celebration of Non-Traditional Students is Wednesday, November 4th from 10:00am – 2:00 pm and will be held at the Campus Center Courtyard.

All students will be welcome to attend this event.

SECTION II. APPROPRIATIONS

A total of \$5,282.50 shall be appropriated from Senate Account 3325232 (University Programs, Services, and Support).
