Senate Resolution 15-17

IN SUPPORT OF THE ESTABLISHMENT OF A YOUTH ADVISORY COMMISSION

BE IT ENACTED BY THE UNDERGRADUATE SENATE:

| WHEREAS, | the Associated Students of the University of Hawai'i at Mānoa Senate is the elected body representing approximately 11,000 full-time classified undergraduate students; and, |

| WHEREAS, | a Youth Commission Board is defined as a "formal body made up of youth who advise high-level decision makers and elected officials"; and, |
| WHEREAS, | "Youth" is defined as "from the age range of fourteen (14) to twenty four (24) years of age"; and, |
| WHEREAS, | a significant amount of the population of the full-time undergrad student body falls within the range of the defined youth; and, |
| WHEREAS, | civic engagement is defined as "the expanse of activities, in which participation in social life with other citizens takes place, involving the pursuit of common goals related to the betterment of the community"; and |
| WHEREAS, | on November 4, 2014, Hawai'i's voter turnout rate reached a historic low of 52.3% out of 706,890 people registered ³ ; and |
| WHEREAS, | issues in Hawai'i that heavily impact the youth are affordable housing, jobs ⁴ , and the increasing cost of education ⁵ ; and |
| WHEREAS, | according to Hawai'i Child Labor Law ⁶ , the minimum age to work is fourteen years old and protections last until the age of seventeen; and, |

- WHEREAS, Proposal 102, which was submitted to the Honolulu Charter Commission for recommendation on October 15, 2015, outlined the need and purpose of a Youth Commission Board, but was not passed⁷; and,
- WHEREAS, the 103rd Senate passed SR 22-16, which supported the passage of Proposal 102; and,
- WHEREAS, Proposal 102 was not approved by the Honolulu Charter Commission; and,
- where with the Office of Youth Services to advise the governor and legislature on issues related to youth; and,
- WHEREAS, the primary purpose of a Youth Commission Board is to provide, comments and recommendations on pieces of legislation, create resolutions that articulate the Youth Commission Board position, and set a policy priorities relating to young people⁸; and,
- WHEREAS, the secondary purposes of a Youth Advisory Commission includes leadership development, encourage the development of civic engagement, and encourage voter turnout; and,
- WHEREAS, the tertiary purpose of a Youth Advisory Commission would allow for a perpetual renewing of responsibility of the community, through the constant involvement of the youth and the ability to promote a diverse community; and,
- WHEREAS, without the formal establishment of a Youth Advisory Commission, the youth is left without formal representation in the affairs of their respective area; and,
- WHEREAS, a Youth Advisory Commission has not been established in the State of Hawai'i; now therefore,
- *BE IT RESOLVED*, the 104th ASUH Senate supports Senate Bill 1220 and House Bill 1466 that was introduced by various members of the Hawai'i State Senate and House of Representatives; and,
- BE IT FURTHER RESOLVED, that the 104th ASUH Senate support the creation of a Youth Advisory Commission through Senate Bill 1220 and House Bill 1466; and,
- BE IT FURTHER RESOLVED, that the 104th ASUH Senate strongly urges the state legislature to ensure the passage of one of these bills to create the Youth Advisory Commission; and,
