YOUR STUDENT GOVERNMENT

Proposed ASUH Constitutional Amendment:

Shall the ASUH Constitution be amended to allow all undergraduate students at the University of Hawai'i to be represented by ASUH?

If the amendment to include ALL undergraduates at UHM to be represented by ASUH is to be adopted into the ASUH Constitution:

- 1) ASUH Senate Rules will be amended to reflect the newly adopted ASUH Constitution and By-Laws
- 2) The ASUH may officially represent ALL undergraduate students at UH Mānoa
- 3) Part-time undergraduates may apply for ASUH scholarships and awards, apply to become an elected member of the ASUH Senate, participate in ASUH events and activities
- 4) Every undergraduate of UH Mānoa shall become a member of the ASUH upon payment of the ASUH fee

AMENDMENT

Article II §A-1: "Every ~~regular full-time classified~~ undergraduate of the University of Hawai'i at Mānoa shall become a member of the ASUH upon payment of the ASUH fee."

Article III §A-1: "The Executive Officers of the ASUH shall be President, Vice- President, Secretary, and Treasurer who shall be full-time classified students maintaining a minimum cumulative grade point average of 2.0 during their term of office."

Article III §B-1: "Only ~~full-time classified~~ undergraduate students who are regular ASUH members shall be eligible for nomination to the offices of President, Vice-President, and Secretary."

Article III §B-2: "Only ~~full-time classified~~ undergraduate students who are regular ASUH members and who have satisfactorily completed at least two semesters of accounting courses or their equivalent shall be eligible for nomination to the office of Treasurer."

Article IV §A-3c: "The ASUH At-Large Senators shall maintain a 2.0 cumulative grade point average and full-time status throughout their term of office."

Article VIII §D-1: "Nominees for the At-Large seats shall be full-time classified regular members of the ASUH."

SECTION II.

Article VIII §D-2: "Nominees for the College Senate seats shall be full-time classified regular ASUH members of the college represented in the ensuing semester."

ASUH BY-LAWS Article I §A-1: "A "regular" student shall be the one who has been accepted as a ~~degree candidate~~ by **[and enrolled at]** ~~one of the established colleges~~ of the University of Hawai'i at Mānoa."

~~ASUH BY-LAWS Article I §A-2: "A "full-time undergraduate" shall be one who is taking at least twelve (12) credit hours per semester."~~

ASUH BY-LAWS Article I §A-3[2]: "An honorary member shall be one who has been designated by the Constitution, Article II, Section B., and who is not a[n] full-time undergraduate student."
