### **SENATE ACT 37-18**

#### BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

## SECTION I. PURPOSE

ASUH neither implies nor accepts any liability as a result of partially funding said events. All reusable items shall be held by the organization Student Parents at Mānoa.

SECTION IV. Any unexpected or unencumbered balance of any appropriation of this act as of the close of business on May 02, 2018 shall lapse into Senate Account 3325232.

SECTION V. The Treasurer is authorized to draw upon said account.

SECTION IV. This act shall take effect upon approval by the Senate.
