. Hawai`i House Names 2017 Committee Chairs and Vice-Chairs

President Kamoshida I've attached the Hawai'i House Names 2017 Committee Chairs and Vice-Chairs for

your information as we get ready for the upcoming legislative session.

ii. Legislation in regards to Additional Mental Health services

President Kamoshida I worked with Higher Education Chair Choy and Vice-Chair Ichiyama. We will push a

bill in for the upcoming legislative session for additional funding for mental health services. I already got in contact with the new Higher Education Chair and Vice-Chair and I will be scheduling a meeting with them shortly to talk about their thoughts on the

bills we will be pushing for.

iii. Legislation in regards to Deferred Maintenance

President Kamoshida During the summer, they did a proposal to increase tuition by 2% for the Academic Years

of 2016-2020 because of the deferred maintenance backlog. They deferred the increase for one year. That doesn't mean they won't do a tuition increase for the following years. With that in mind, I've been working closely with Ichiyama and Choy to push in a bill for deferred maintenance. Rather than having the students pay for deferred maintenance, we would ask for the state to pay for deferred maintenance. I will update you all. They are in

the process of writing the bill, which I will be assisting them in.

Senator Lao Aren't some of the funds in the Biennium Budget going to go towards Capital

Improvements, or are Capital Improvements different from deferred maintenance.

I believe the language of the bill is to prevent the use of student tuition towards deferred maintenance and place that on the state. This is more of a protectionary measure rather than an allocation of funds.

A significant number of protests have been student-led, which is why we brought this resolution to the Senate. We think the students at UH can be susceptible to this behavior. While it is still politically salient, I think UH should make a stance against the riots. We aren't saying that we are in opposition to the results, nor are we saying through this resolution that we are against protests. As the voice of the UH

undergraduates, we would just be saying that we are in opposition to the violence.
