- B. SAL Sasaki:
  - a. Current work on SR02-25
    - i. To be done ASAP, presentable
    - ii. Unsure of completion due to school projects time conflict and precedent
    - iii. Any assistance would be much appreciated and is in urgent concern of ASUH and other CSOs
    - iv. To be used for a Presidential Project account
  - b. Previous UH Presidents have done external funding to make their own initiatives happen, duly noted
    - i. Refer to documents from President Reed, contact for further information
    - ii. Will affect the internal staff who facilitate U-Pass initiatives
    - iii. Seems immensely suspicious
  - c. Portion of our acting budget will be ceased due to current line items connected to aforementioned accounts
    - i. Cash in university accounts expended to pay for initiatives implemented by students

- ii. When cash account is at a concerning capacity, stock portfolio to be reviewed and evaluated, then deciding on a suitable withdrawal
- iii. ~\$200,000 amongst the collective CSOs proposed for this initiative
- iv. To be collaboratively covered, possibly in-person over the weekend
- v. Let President Reed know as soon as possible

C. President Reed:

- a. Internal funding concern
  - i. Line item C4, Native Hawaiian Place of Learning fund
  - ii. Designated for NH events/programs
  - iii. Have reached the budget for this semester for equality of budget
  - iv. However, it is possible to propose an increase in this budget
  - v. Please consider discussing with peers about what kind of events/programs are to be planned
  - vi. Seek out Finance members ideally to facilitate these amendments
