Official Correspondence

a. Kalbert Young - Vice President for Budget and Finance/ CFO for the University of Hawaii System

President Zakimi

We have Kalbert Young the Vice President for Budget and Finance of the UH System. He will be giving us a brief overview of what will be happening at next weeks meeting with the state senators.

Vice President Young

Senate Ways and Means are one of the more powerful committees on the state legislative. They are the money committee of the senate. There are a number of things going on in the legislatures. We have an office that is under the Vice President of Finance, which is Government Affairs. We do a lot of the legislative advocacy work for the UH system including Manoa campus. The legislatures will be coming to campus next week. They asked to meet with ASUH casually over lunch next week, just to hear some input from students. So attending next week is, Senator Chun-Oakland, Chair of the Senate Human Services Committee and she also part of the Ways and Means Committee. Jill Takuda, she is the Chair of the Senate Ways and Means committee. Senator Donovan Dela Cruz Vice Chair of the Senate Ways and Means Committee, more importantly he is the chair of the sub committee. He will determine what capital projects/ construction projects get funded. It is important for Manoa and the buildings. We have been pressing funding for capital movement projects. Senator Brian Taniguchi represents this district. Senator Glenn Wakai he represents Moanulua district, he is a staff member. Robert Sato is also will be attending, he is a staff member of Senator Breen Harimoto's office. Catharine Higa, she is the staff member of Senator Sam Slom's office he represents Hawaii Kai he is the only republic in the state senate. Ways and Means staff will also be attending. Let me tell you a little bit of what happens. We will be picking them up at 11:30 in a shuttle and bring them to Manoa. Lunch will be in QLC 412 and this lunch will be casual. They will probably ask you, what concerns you? And what do you think the university could do better. At 12 to about 1:15 for lunch and then they will be touring certain building on campus. I already mention about the differ maintenance is really bad. I am really familiar with the budget of the state. I would say the university is not successful for its budget. For the last three years, we have been pounding on the capital projects of differed maintenance. General Obligations bonds are a debt on the State of Hawaii. The State of Hawaii will pay for the university for funding the differ maintenance. Legislature said no to revenue bonds because it comes from tuition, which would have raised it. So university is now stuck with differed maintenance. We do not have funds to pay for the differ maintenance. 75% of the university is residence. This is the only public university.

Senator Shon

Can you please remind me where the funds are coming for the housing area?

VP Young

Back in 2010 the university had a chance to sell bonds for improvements for the dorms. The university sold \$130 million of revenue bonds which went to a portion to student housing. Revenue of the bonds came from the facilities that were built, housing fees and supported from the general revenues of the university of Hawaii. This all goes to supporting that debt. Manoa wants to build more student dorms. The funding for that does not currently exist. The plan is to ask for either for general obligation bonds, but past practice indicated. Second option revenue bonds can be used, but its gonna be tuition. Third option is revenue bonds, is sold by the university but only using the revenues coming from housing that does not exist right now. The closes would be the bonds using to build the medical school. The housing plan for Manoa is an excess of

\$200 million dollars. Unless you want to see the increase of housing fees increase. So again on defer maintanance we are pressing increase funding. We will be pressing Manoa for improvements We are asking \$80 million dollars for GEO bonds. This year the university got \$44 million dollars for maintenance. Last year we got a little more which was \$65 million dollars. The last 10 years the university did not get at least \$150 million dollars. The big reason the university is getting difficulty to get this type of funding is because, every department in the state of Hawaii is asking for GEO bonds. There is a fine line of bonds the legislatures can give out for bonds. The legislature cannot give everything, but everyone get a piece.

Senator Shon

Is there a place where we can see where are monies going to for the buildings?

VP Young

Every quarter I present to the regents a list of capital projects that campuses are working on. There is not a lot of money going around. When it comes to University of Hawaii. We do not have enough money to fund all campuses. There is an issue passed by regents years ago, the University of Hawaii will not fund construction of new facilities on any campus until that campus has addressed their differed maintenance issue. It hits at the heart of Manoa. Manoa because it's the largest campus, its differed maintenance is much larger about \$440 million. So differed maintenance will be a big push. The top priority buildings I pushed need to be repaired. We will be asking \$80 to 100 million for deferred maintenance and why it is critical to fund these building. The softball field improvements were approved \$100 million for maintanance. We are going to sneak them to T.C Ching field as well. We have budgetary ask as well. The unvieristy of Hawaii gets funded from different sources like, state tax dollars. Its about \$400 million a year, about \$300 million ends up in Manoa, another 30% is fees. General fund is a big deal.

Senator Shon

How much does it take to run the university?

VP Young

About \$170 million a year. The University System takes about \$1.1 billion a year. Just about \$70 million for Manoa. Majority of the money is given for research because Manoa is the only research campus. A big portion is driven by research, driving a lot of funding. The general funds are important. The fluidity of funds, getting a dollar and the source coming from. General funds I can use for anything and anywhere. The comparison is tuition dollars which is limited. Operational cash is important because its pretty high and using labor. 60-79% is used for labor, paying for faculty or staff. The cancer center is where investments are being put into. This past year \$6.5 million was approved by legislatures for the University of Hawaii for performance under student achievement. Now I am asking all the campuses if you want a portion for the campuses, what you are using it for and for student achievement competing with other campuses. We will send it to the highest success of management availability.

President Zakimi

Sorry I have a few clarifying questions you said they will be touring, Dean Hall, Gartley and Edminson. But, Gartley and Edminsion were recently renovated? Is that just to show the contrast?

VP Young Yes

President Zakimi My other question was the university asked the legislature for lump sum?

VP Young Yes and No.

President Zakimi Does the legislatures see the different line items we are asking for?

VP Young Yes, typically for certain projects like Snyder for \$50 million and \$80 million for deferred maintenance for the system. The legislatures will ask where that 80 will end up.

This is a political process. Community colleges will have different appropriations lay \$ 20 million and we share the \$80 million. This is just the landscape. We expect the legislature will ask why Snyder? We want them to fund Snyder \$50 million and \$80 million for Manoa.
