Begin Testimonies

Diane Marshall

This is for your resolution on the Hawaiian language bill. Thank you for the opportunity to provide testimony in support with amendments to your resolution. My name is Diane or Kiana Marshall and I humbly sit before you as the non Hawaiian who doesn't speak Hawaiian author of the original version of this bill. The Hawaiian Language was re-recognized as an official language and signed into law by the 1978 State Legislative Constitutional Convention. However, nearly 40 years later, government documents, publications and pamphlets are still not available in the official language. For example, the 2016 Presidential, State and City & County Election process had information, reminders, ballots and all 20 C&C Charter Amendments available in Japanese, Chinese and Ilocano, but not “available upon request” in Hawaiian as claimed. The justification that all Hawaiians can understand and speak English! Currently, there are over 26,000 self reported fluent Hawaiian speakers nationwide with 18,700 living here in Hawai'i (Senate Resolution 97 S.D. 1 Information Briefing 1/10/17). Over 3,705 children are currently enrolled in Hawaiian Immersion Schools. (SR97SD1 Informational Briefing 1/10/17). According to the working group of SR97SD1, the goal at both the University of Hawai'i Mānoa and UH Hilo is to increase the number of 'Ōlelo Hawai'i speakers both on and off campus thus helping the “move towards normalization of the Hawaiian Language.” SB643SD1 is a step in the right direction, considering the expected growth of fluent Hawaiian speakers in the academic, professional, media and labor workforce. Keeping in mind the final goal of printed Hawaiian government documents, publication and pamphlets as the norm. Hopefully, encouraging local mainstream publications to print both English and Hawaiian versions of their materials helping to “normalize” spoken and written Hawaiian. Thank you very much for your time and consideration.

Melinda Sonoda Pale

I am here as an alumni of UH. I also wanted to share of the bill that your resolution is supporting. It is still alive - it passed through the Senate and will crossover to the House. It has a lot of support. There were 200 testimonies that came in. There were testimonies from the Hawaiian Language Department and Hawaiian Kupuna, as well as organizations such as Keiki O Ka `Āina, which is a non-profit and provides bilingual programs. VC Delos Reyes

External Affairs and ASUH as a whole have been focusing on this mental health bill, and I am happy to report that both SB 1164 and HB 967 have been passed through their respective committees. We are just waiting on the next hearings. In our meeting, we would like to get testimony and raise general awareness through tabling. Many of you have probably seen the graphic our graphic artist Eileen has created, so please distribute that. Vice President Dela Cruz has been kind enough to take on the coordination for the tabling, so be on the lookout for that.

I'd like to reiterate that we will be tabling to get testimonies. In addition to that, there is another bill we are tracking, HB 1600. ASUH has supported similar initiatives in the past. The Colleges of Arts and Sciences is barely making it fiscally. The introducers of this bill want to create dialogue that'll affect the students en masse. Essentially, everyone has to take classes from this college. In some shape or form, this college touches each of the students at UH. They want to make sure that the students understand there are certain budgetary shortfalls and this needs to be addressed. I will be scheduling the introducers to meet with us on March 1st so we can gain an understanding on how ASUH can get involved. Coming up on February 25th is the Mānoa Experience, an outreach for incoming students. We need your help from 9am-1pm. There will be one-hour shifts. An email will be released for you to sign up. This is an opportunity for you to reach out to students.

VC Delos Reyes

There are two bills legislators have approached ASUH about in regards to providing testimony. They are asking us to give them feedback on SB 10-19 and HB 1153, which will completely prohibit smoking on all UH campuses. Senator Kahele expressed to me they want testimony regardless of your stance. If this is something that is important to you I strongly suggest you submit testimony. HB 1162 and its companion relating to the Hawai'i Promise Program was passed with amendments in the Senate. HB is still waiting for a hearing. This is extremely pertinent to all of our constituents. This promise program will provide scholarships for unmet needs of local students enrolled at any UH campus. I hope you will disburse this information to your constituents.

A lot of residents have approached me regarding the concerns students are having of the safety at student housing, especially with the emails that are sent regularly about the crimes that take place on campus such as thefts, burglaries, and the recent sexual assaults. I have statistics in this resolution of how many crimes have occurred on campus and survey results on how safe students feel. I researched on what DPS does and I found their 2016-2019 strategic plan, in which they plan to implement several additional crime and loss prevention services, one of which being a closed circuit television system at public places around campus. This resolution is to request a comprehensive, detail-oriented, and timely implementation of the Department of Public Safety's Strategic Plan as it relates to crime and loss prevention in and around student housing and facilities. I did want to stress that the reason why this resolution is specifically centered around student housing is because it is somewhere that students have to spend majority of their time at. For example, on the second page, the last three *WHEREAS* statements are talking about the current proposal. I would only change it at referential marks. Again, this is only for your consideration.

Advisor Manini Because we are talking about the name of this entity, I would recommend that you make a motion that allows for the correct name to be used when codification happens through consultation between Shanda and Scott. This doesn't change the intent of these motions.

Senator Negrillo This would give you the option, you don't need to have meetings during the weekend. All of the meetings are posted, so whoever wants to attend can attend.

Senator Arenivas Shouldn't these meetings be when students are on campus?

Senator Lao That is one concern I had when drafting this. Would it alleviate the issue if only committee meetings can be held on weekends?

Senator Arenivas Yes, my only concern was with having these general senate meetings on weekends.

Senator Lao Move to have 19-2 read Senate and Executive meetings may not be held on weekends or state holidays, and add 19-2 a) stating Standing Committee meetings may be held on weekends.

SAL Willis Second.

SAL Chen In general, is it correct that Standing Committee meetings do not officially strike bills?

Advisor Manini That is how ASUH has operated all of these years. Measures still need to be seen in the General Senate meetings and final decision making is made at the General Senate, not by Committees.

Advisor Sonoda Pale I have a concern about this. If the meetings are held on Sundays, there may not be rooms available since that is concerned overtime, so there might not be staff available to set up the rooms.

Senator Negrillo We don't need to hold meetings in a room, we can hold them in open public spaces on campus, as long as the meeting takes place on this campus, according to Rule 19-3.
Motion rescinded.

Senator Wang Move to add a subclause 19-2 a) "Senate and Executive Committee meetings may not be held on weekends."

SAL Chen Second.
Motion carries.

Advisor Sonoda Pale I just wanted to let you guys know that if you have your meetings on weekends, office staff can't help to get your documents together, since they won't be here. So, you will need to plan ahead.

Senator Leval Move to call the question.

SAL Chen Second.
Motion carries.
