**NEW BUSINESS**

**a. Senate Bill 02-24 TO REALLOCATE FUNDING FOR FISCAL YEAR 2023 (2022 - 2023) Second Reading**

*Advisor Manini had several recommendations in the comments of the documents including: 1. Amending the title to include SA 12-23 and SA 33-23, 2. Amend the Senate account from #3325232 to #3325242 which is the RIO account, and 3. Amend provisions to specify that, "In order to receive awards RIOs need to be formally registered as RIOs with the Office of Student Life and Development."*

*Senate Li made a motion to adopt the recommendations and refer Senate Bill 02-24 TO REALLOCATE FUNDING FOR FISCAL YEAR 2023 (2022 - 2023) Second Reading to the General Senate for final reading. Senator Hermoso seconded the motion. This motion was approved unanimously.*

**b. Senate Bill 03-24 Second Reading**

*Advisor Manini had a few recommendations. It was to Amend SECTION II: APPROPRIATIONS to condense T-Shirts and Printing, Screening, and Tax lines into one line: Promotional Items.*

*Additionally, to amend all giveaway language to "event". Advisor Manini also noticed that the bill had two different University accounts listed in SECTION II and SECTION IV; she says that it's the wrong account listed in section four. The last four numbers of the account should be 5232. Finally, she says that if this bill is enacted, it needs to be decided how the shirts will be distributed and who will receive the shirts.*

*Senate Goo made a motion to adopt the recommendations for Senate Bill 03-24 Second Reading. Senator Hermoso seconded the motion. This motion was approved unanimously.*

*Advisor Manini made one more suggestion. It was to change the appropriations to come from the Hawaiian Place of Learning account instead of the General funds so as not to affect our spending.*

*Senator Li made a motion to refer the amended Senate Bill 03-24 Second Reading to the General Senate for final reading. Senator Hermoso seconded the motion. This motion was approved unanimously.*

**OPEN FORUM**

*Senator Goo asked Advisor Manini if we need to create SCRs for the two bills that were presented today. Advisor Manini said yes.*

*President Azama said that an opportunity to select a legislative fellow. Advisor Manini said that this position allocates a sort of scholarship; it is \$2,500 a semester. The role would be to keep track of legislature and advocate for legislation that we would like to chime in on.*

*Senator Hermoso was the fellow last year and said talked with the Senator Chair for Higher Education. He said it was a good experience for him.*

*Advisor Manini suggests that we be very transparent with our communication with other Senators, Legislators, and the study body.*

*President Azama said that Amy Peruso will be speaking with the ASUH at an October 26th meeting. There is also a proposal from the individuals who run student housing for rent increases, so the ASUH will have that group present as well.*
