SAL Negrillo Welcome everyone and thank you for attending our meeting. For everyone testifying

tonight, you will be given three minutes and I will notify you when you have one minute

left. We will begin with Eugene Lao.

Eugene Lao Before I begin, may I request that the Senate give me extra time if I do need it. I think in

five minutes I'll be able to say all that I need to say.

SAL Negrillo What we'll do is, is that we'll give you the allotted three minutes and if we feel that you

need more time we will give it to you, but for now you have the three minutes.

Eugene Lao My name is Eugene Lao. I was serving as the Chief Elections Officer until the last

Executive Committee Meeting where, I believe, you approved my request to be on-leave.

My reasons for the request to be on leave is due to all of the issues impeding our

My reasons for the request to be on-leave is due to all of the issues impeding our Elections process, which has taken a toll on my mental health, my physical health, and my academic performance. I have no obligation or responsibility to be here at this point, but I am here anyway because my Vice Chairperson, Cody Dunham, could not attend. I do not hold this against him because normally we would only have General Senate Meetings every other week with tonight being an exception. He has work and cannot make it. My second reason for being here tonight is what I believe to be my ethical obligation to those perspective nominees. Thus far you have known me as the Chief Elections Officer. I have been in contact with you all so I felt that it was my duty to answer all of your questions that you may have. Lastly, my reason for attending tonight is to defend myself because I have heard that there has been a lot of rumors going around surrounding my involvement in this Election. There has been some accusations regarding

whether or not I have been fair or unbiased with my judgement. I would like to move onto a timeline of how these Elections have essentially preceded. On July 11th, I believe I forwarded to those who are currently on Senate a tentative calendar of the Elections and the seats available. On July 25th, this body approved a rule revision regarding the

Election rules. Those rules that were specifically changed affect the nomination process

and the voting process.

President Dela Cruz That is all the time we have for you. I know in the beginning you expressed wanting to

extend your time. Did you still want to do so?

Eugene Lao Yes. Will the Senate be willing to let me do that?

President Dela Cruz It seems that Eugene still has yet to make his point.

SAL Negrillo Eugene, do you think you would be able to make your point in two minutes or even one

minute?

Eugene Lao I'll try to speed it up.

SAL Negrillo Move to add a two minute extension for Eugene Lao.

Senator Balico Second.

President Dela Cruz

I just wanted to clarify for everyone, when it comes to extending time we have to do a two-thirds roll call vote because we would technically be going against our rules.

Eugene Lao

I'll make this quick. We had two rule changes. One being that prior to the rule revision, you would either be nominated by obtaining twenty-five signatures from students in your college and previously there were real no stipulations on when you would have to submit a floor nomination request, so a lot of candidates who knew a Senator had an unfair advantage over those who obtained the twenty-five signatures. After this rule revision, there was a stipulation included that floor nomination requests must be received one day in advance and must include the name, the position sought, and reason for requesting to be floor nominated. This backfired on us really hard, but I did not think this was a bad rule change by any means. I think this was a failure on the Senate members to know the rules and make them known. After we approved this rule change on July 25th, all Senate members, particularly those in the Elections Committee and the Internal Affairs Committee, should have known this. The packet was released on August 20th according to the ASUH Constitution. Perspective candidates who had to turn in the Elections Packet on July 12th had no excuse to not know the rules. If you turned in a packet, you signed a form that stated that you agree to abide by the rules included in the packet. Moving forward to the General Senate Meeting on July 12th, last week Wednesday, there were ten candidates who met the requirements that I stated originally, seven of which were running for Arts and Sciences. At the meeting, I brought up that we could suspend the rules to allow for five more Arts and Sciences candidates, making it twelve candidates running for ten seats. I was made aware of nine additional floor nomination requests at 6:14 PM, fourteen minutes into our General Senate Meeting. Seven of these were for Arts and Sciences.

SAL Negrillo Micah Leval The next testimony we have is from Micah Leval.

Good evening Madam President and members of the 106th Senate. For those who haven't met me yet, my name is Micah Leval, former Senator-at-Large, and Chairperson for the Committee on External Affairs. I am also a candidate for Senator for the College of Arts and Sciences for this Fall Special Election. I'm here to express my views regarding the unfortunate situation ASUH has found itself in regarding the Fall Special Election. As a former ASUH Senator, it is really disappointing to hear that there has been so much confusion over a process that should have been relatively simple. It is important to point out that the only rule that was suspended at the last General Senate Meeting was the one that mandated floor nomination requests be submitted one day prior to the General Senate Meeting. This suspension of the rule does not change anything else. It does not change any rule that candidates are held to or the deadlines pre-defined in the Elections Packet. This is especially true considering that rule 49-2 states that the Elections schedule must be finalized prior to the nomination period, i.e. when the Election Packet is released. Suspending one rule does not change ASUH's obligation to uphold all other rules. This is aside from the fact that many Senators would not have voted in favor of the rule suspension if they knew all of the implications of their vote. This is also aside from the fact that rule 48-4 b states that ignorance of the rules is no defense for elections infractions. Even if this ignorance falls upon someone on Senate, it still falls on the candidate to know what is expected of them, especially since the Elections Packet was available since the first day of school. Therefore, all I ask of you tonight Senators is to follow the rules. Make a decision based on what is by the books rather than what people

may infer, desire, or assume. There is no doubt that the ASUH will have to honor the rule suspension it bound itself to last week, but that's where it needs to stop. All candidates should be held to all other rules and deadlines stated in the Elections Packet, which again, according to the rules, needed to be finalized before this all even happened. If the applicant followed the rules, they should be allowed to run. If they did not follow the rules, they should not be allowed to run. In other words, please respect the decision made at the unofficial Elections meeting this past Monday. Lastly, I want to take the time to remind every member of the Senate that they have the power the make their own individual decision on this matter. Please do not think that you have to act based off of one person's recommendation or opinion, including my own. Please consider all stakeholders and vote for what you think is right. During the Senate discussion of this matter, please feel free to ask me any questions you may have. Thank you for the opportunity to testify.

SAL Negrillo Raiyan Rafid Thank you Micah. The next testifier is Raiyan Rafid.

My name is Raiyan and I am running for Senator for the College of Arts and Sciences. I was interested in running for Senator and got an Elections Packet and went through the rules and followed all of them. I was happy with ASUH and was excited to get involved. This afternoon, I was made aware of changes that were made and it made me upset. I went around and got twenty-five signatures and talked to twenty-five people. After I found out that the twenty-five signatures that I got were not entirely from my college, I had to go back to the Elections Committee Chair and had to request to be floor nominated. I did that within the timeframe. When I heard that people requested someone and the Elections Committee is now making changes, I think it isn't fair. I like competition, don't get me wrong, but I don't think it's a fair competition. Thank you. Now we have Ismael Salameh.

SAL Negrillo Ismael Salameh

Good evening. I don't know anything, that's the truth, and that's really the instance of the problem here. I am a candidate. My name is Ish and I am a transfer from KCC. It was at KCC where I served on student government, hence why I am so passionate about this. If we take a break, we should realize that this is a good problem to have, the fact that students want to get involved and promote change. That's a good problem to have. At KCC, we were begging students to join. This isn't as severe as we thought it was.

rules. With the two-third roll call vote this could be passed or denied.

Senator Juliano Just for clarification, if we do approve of this new schedule, everyone who wants to be

floor nominated will have extra time to turn in their packet?

President Dela Cruz If we approve of this, whoever gets floor nominated tonight will have until Friday to turn

in their packet.

Advisor Manini Normally when floor nominations happen, everyone gets an additional two days to get

their packet in if they were floor nominated. This has been going on for years. That's why there's a change in the calendar. Last week, you all decided to postpone the decision and move the floor nominations to this week. In doing that, there's a need to adjust this. When you get to floor nominations, you can make the decision on whether or not you want to add names. That's a different conversation. Those who will be floor nominated

will have the additional two days to turn in their packet.

VP Simeona How far off does this divert from the original calendar?

President Dela Cruz Instead of all of the Elections results being ratified at the October 10th meeting, which is

the General Senate Meeting prior to what is listed on here. That would be two weeks. The Elections results can only be ratified at a General Senate Meeting, which only happen

every other week.

Senator Ramirez Just a reminder, last week we were not able to nominate those who are running for

colleges who had no candidates like Business and Education.

VP Simeona Advisor Manini may correct me on this if I'm wrong, but the Elections Chair can extend

the deadline for vacant seats.

Advisor Manini That sounds like a floor nomination discussion instead of a schedule discussion.

iSecretary Sakamoto Just another question, where does the written request to be floor nominated fall on this

schedule?

Advisor Manini At this point, it would just be based on what's in the rules. It would still be the twenty-

four hours before floor nominations, but when we get to floor nominations, who knows if you all are going to suspend rules or not. It's going to be based on what you guys decide. Although it's not on the schedule, we would still have to follow the rules that states it has

President Dela Cruz Although it's not on the schedule, we would still have to follow the rules that to be in one business day in advance, which would have been yesterday.

Senator Juliano Would voting to approve this go against what was testified earlier?

President Dela Cruz That might be more a matter of your opinion.

VP Simeona Just to remind the Senate to vote what you think is right. Senator Hortizuela If this schedule does not get approved, what happens?

Advisor Manini If this schedule does not get approved then the old schedule stands. If we cannot follow

the old schedule because we are already late, then you will be in violation of your own calendar. An entire week has gone by and in that week I'm sure there were things that were already supposed to be happening that didn't. If this doesn't pass, you will probably be in violation. I recommend looking at both this calendar and the old calendar so that

you can all be as informed as possible before you vote.

I see that it says that the nomination period ends on September 14th. Currently, the

nomination period is over. Is that correct?

Advisor Manini

Yes, but because you postponed the nominations to this week, the candidate list, which should have been posted, did not get posted. The reason that the candidate list has to get posted is because it has to be public so that the people voting can get information about the candidates that are running. I don't believe that is currently on your bulletin board. We are already in violation of the current calendar. You have to change the calendar so

that you're not in violation.

SAL Li

I would like to make it clear that if we vote "no" on this new calendar, that would mean

we won't be able to nominate anybody.

Senator Juliano

If we vote "no" on the new schedule and go back to the old one, could we motion to

change the dates we missed?

Advisor Manini

You could use the old schedule as your template and amend date by date, but in the rules sometimes it says that there needs to be so many days between one thing and another. If you start picking one date at a time, you may be in violation of these rules. In this revised schedule, it should be consistent with the rules. If you start changing dates one by one and violate the rules, you all are going to have bigger problems.

Senator Oshiro President Dela Cruz Are we able to view the rules that state how many days need to be between each date? Yes. Our Internal Affairs Chair can verify whether or not we would be in violation of the

rules or not.

Advisor Manini

If there are people who want to amend certain dates of the old calendar instead of switching over to the revised one, I would recommend taking a recess so that you can sit with the Internal Affairs Chair and see whether or not the dates are aligned with the rules.

Senator Hortizuela Was there an email that the written requests had to be sent to?

Chairperson of the Elections Committee. I did want to verify that while Eugene was Chair, he did make a list of those who turned in the requests so we would be able to verify some of these names on here. Whatever Vice Chair Dunham added to this is based

on what he received.

Advisor Manini So that we're all clear and that we accomplish what needs to be done tonight, is it too

much to ask to go person by person and see if they have the necessary documents?

Do we have all of the written requests compiled? SAL Li

President Dela Cruz I have a list of names of people who submitted the written request.

SAL Li Up until what point?

SAL Li

President Dela Cruz The list that I have is up until Wednesday and this was made by Eugene Lao. Any

> requests Vice Chair Dunham would have received, their names should appear on this list. Can we get the actual documents to confirm? Right now we're going off of assumptions and lists that other people have made. We need to know for certain who sent them in.

I apologize SAL Li, but I don't think we can do that considering these documents have President Dela Cruz

been sent to multiple emails and not everyone on Senate has access to those emails.

If Eugene compiled a list and because he was the acting Chair at the time, I think we Advisor Manini

should respect that he would not put a name on the list that did not turn in the requests. This is the best we are able to do. With Eugene going on-leave, anything that happened from the 17th would be the Vice Chair's responsibility and we should respect those names that he added. If we can get those names approved for the ballot and then deal with

the other names afterward, I believe we'll be taking a step in the right direction.

I know we have been discussing this document as if Vice Chair Dunham is the only one Senator Oshiro

> inputting information, but he sent an email saying, "To streamline the process, I started a Google Doc that you all can fill out to be submitted at the meeting. Make sure you have

all necessary information filled out in the document!" I thought this meant that we input

the names of people we plan to floor nominate.

President Dela Cruz If you put someone's name on this list that didn't turn in the written request by yesterday,

which was one business day in advance, then we would, currently, be in violation of our rules. If they have turned in some sort of written request to ASUH then they are eligible. I know Vice Chair Dunham sent that email, but we need to be in compliance with our

rules.

Senator Oshiro I instructed the person I added onto the list to submit the written request, but she never

confirmed with me that she did, so I can't verify.

Senator Juliano So Eugene compiled a list of candidates that submitted the written request. Do we know

if Vice Chair Dunham went off of that list first and then added anyone else?

SAL Li Vice Chair Dunham only added the top five names on the list.

Advisor Manini Are the first five names that were added by Vice Chair Dunham from Eugene's list?

President Dela Cruz Yes.

Advisor Manini Okay, so the first five names are verified. If there is no opposition to that then I think we

should approve these names and get them onto the ballot.

Senator Ramirez I sent in all of the documents to Eugene last week.

SAL Kim I don't know if this is true or not, but Eugene mentioned last week that the timestamps on

the screenshots you sent him only said "Today" and we aren't able to tell the actual date.

Senator Ramirez Those were all sent last week so I added the names of those people.

Senator Hortizuela Your floor nominations sent in the written request to you?

Senator Ramirez Yes, on Wednesday.

Senator Hortizuela Did they send it to Chair Lao or the ASUH email?

Senator Ramirez No they did not give it to them.

Treasurer Honda I just wanted to remind everyone of the testimony that we heard earlier. I don't think this

is fair to the candidates who met all of the original requirements. I recommend we stick with the nominations that we already approved. I would love to see more people running in the Election, but I don't think this is setting good precedent. We can't bend the rules

whenever things don't go our way.

President Dela Cruz I know you all are concerned with the verification of all of this. We do have Vice Chair

Dunham on the phone. We're going to confirm that we can put him on speaker so that he

can help us verify the names.

Senator Urasaki If we can verify that these people turned in their written request one business day in

advance, we would not be in violation of our rules and the calendar that we just approved.

SAL Li Because of that schedule we just passed, everybody who turned in a written request up

until yesterday should be able to be floor nominated.

Senator Oshiro I know we're accepting floor nominations for people who sent in their written request up

until yesterday, but there's still a rule that states that if there's a completely vacant seat

we can floor nominate someone for it?

VP Simeona Yes and that is up to the decision of the acting Chairperson of the Elections Committee.

Advisor Manini If we can hold that off until after we finalize this list, that would be good. If we insert that

right now then things could get confusing. Don't let the meeting end without bringing

that up.

President Dela Cruz Vice Chair Dunham is on the phone and I would like to give him the chance to speak. To

Vice Chair Dunham, people may or may not have questions to ask you. Everyone please

have your questions ready and please be concise.

SAL Li Vice Chair Dunham, do you happen to have a list of the people that submitted to you

their floor nomination requests up until yesterday?

VC Dunham The names that were submitted by yesterday at 4:00 PM are all the names up to Chachi

Abara. All other names were added starting September 19th at 3:00 AM.

Advisor Manini Does he know if the other names submitted the written request before vesterday 4:00 PM

and they were just added to this document late?

VC Dunham I do not have anything besides from the first five names on the list. I don't know if

anything was submitted to Eugene. I am only sure about the first five people on the list.

President Dela Cruz On this spreadsheet that Eugene Lao made, he added names that neither submitted a floor

nomination request on time, according to the old schedule, nor did they submit

signatures. Do you know if they did submit a written request, but it just wasn't sent in on

time according to the old schedule?

VC Dunham He used color coding. If their name is highlighted in yellow then they would be okay to

floor nominate if we changed the schedule. Everyone in green and yellow should be fine.

President Dela Cruz Great, I think that's all we needed to know.

Advisor Sonoda-Pale I have the written requests from Senator Ramirez and some of these people are on this

list. I think we should go down the list one by one.

President Dela Cruz I am going to work on verifying this list and whatever Advisor Sonoda-Pale can verify

we'll verify. I also want to note that there are people who are not on this list that submitted the written request, so we can verbally nominate those people. I'm going to confirm all of the names of those who submitted the written request. Nicolas Regaspi, Raiyan Rafid, Matthew Easter, Camille Dahmen, Tiana Elisara, Kylie Johnson, Justin Friedman, Karimah Bunn, Michelle Yim, Tristan Ross, Jaclyn Sakamoto, and Chachi

Abara are all verified.

SAL Li What were you reading these names off of?

President Dela Cruz The list that Eugene made. Vice Chair Dunham confirmed that those highlighted in green

and yellow submitted the written request. Sarah Onishi, Marcus Patterson, Luavaasiitia Esera, Ryan Su, Lauren Kobayashi, Laura Lenhart are all also verified. On this document presented to us, all names that are highlighted in yellow may be floor nominated because

they sent in a floor nomination request on time.

SAL Chun Are we able to see these written requests?

Advisor Manini Please have these documents sent to the Senate.

iSecretary Sakamoto I would like to strike "Senator for Arts and Sciences" where my name is found on this

document so that it only has "Secretary" under the "Position(s)" column.

President Dela Cruz This means that none of these people are able to participate in the Special Election.

Senator Oshiro Does this mean that we have to floor nominate people individually?

SAL Negrillo That would be an option, but we could also have a discussion and go through the list to

find some sort of middle ground.

Advisor Manini If you don't have a floor nomination list, you are in violation of the Constitution. By

voting against this list and not allowing people who submitted everything to be floor nominated, you are in violation of the rules. Are there people who are highlighted yellow

that people feel do no meet the requirements?

Senator Oshiro Normally when we have floor nominations, don't we normally just verbally say who we

want to floor nominate and then those people will get added to the list?

SAL Negrillo That used to be the process, but now because of the rule revision, we have a premade list

based off of who submitted the written request.

Senator Urasaki I'm under the impression that the written request is only a request that has to be approved

by us.

SAL Li What used to be the process for floor nominations?

Advisor Manini Before, anyone could be floor nominated. Anyone who wanted to be floor nominated

would get added to the list and that would be it.

SAL Li In theory, if we suspended the rules, would we be able to floor nominate anyone?

Advisor Manini If the rules are suspended, that would open up the floor nominations to anyone and we

would be able to add any names that aren't already on this list.

SAL Li I would like to explain why I voted in favor of this floor nomination list. I do believe that

it is unfair that some people did not turn in packets on time, but what we don't see is that

there has been a gross failure on us to really do our due diligence to make sure that the rule that was passed this summer was followed. I do not feel that it is fair for us to punish those who want to run for us not making it clear of our deadlines. We just spent thirty minutes looking for a list that we couldn't find. There is disorganization on every level. Because we could have done a better job, we should not be punishing these people.

Senator Oshiro I know we rejected this list, but if no one has an issue with it, are we able to go back and

re-approve it?

Advisor Manini Someone who voted with the prevailing side would have to recall the motion and there

would have to be a second then you could discuss the list then vote on it again.

SAL Negrillo For those who still haven't spoken, why did you vote no? Even though it took thirty

minutes, we were still able to go through the list and verify and highlight the names that

we deemed certain were eligible. What is the problem?

Senator Urasaki In rule 50-4 c, it says that the disposition of all floor nomination requests shall be left to

the discretion of the Senate. I was under the impression that we were going to be able to see the requests and the reasons why people were requesting to be floor nominated.

Advisor Manini The Constitution states that you must have floor nominations. I don't think people

provided long narratives in their requests about why they are seeking floor nomination. I'm sure they just provided what the Elections Committee asked for. You all are expected

to act fairly.

Treasurer Honda In my prior discussion with Eugene, he told me that he was going to go through the list

and explain his reasoning for whether or not we should approve them. However, he was not given time to do his full talk and give his reasoning. As a recommendation, I feel we should give our testifiers more time. I talked to Eugene and he was actually going to do

an explanation for reasoning.

Senator Juliano I think it's unfair that we had to give people that extra time to allow people to be

nominated, but I would like to move to recall the floor nomination list.

Senator Urasaki Second.
