Advisor Manini I would recommend to double check that that is an option. I think it is premature for the

I think it is premature for the Senate to decide on this because they need to know if they're going to have student representation on that committee. If Michelle Tom and the committee are not prepared to have another student sit on that committee, then she should not be removed, otherwise

there would be no student voice.

Chairperson Lao It was not my intention to leave the seat empty. I have not confirmed with the other

candidate if he would still be interested. I know he is still in the major because he is

running for the seat for Hawai'inuiākea.

i. Updates Regarding Sinclair Library Hours of Operation

President Dela Cruz I just wanted to update the entire Senate. To summarize this past week and a half, the

committee has met nearly every day to decide on alternative solutions and how to approach this issue with meeting with administration, and seeing what we could do regarding the previously made changes. I arranged a meeting with the Interim Chancellor Lassner to negotiate possibly repealing the announced changes, and if not, compromising on a change. The result ended up being that he was truly sorry on his behalf and on behalf of Vice Chancellor Bruno for the lack of student consultation. There was also some

miscommunication within the administration which led to this point. President Lassner read through the student testimony and he agreed on having the hours changed to close at 2 are instead. A SULU's position on this is that we are greateful for this compression.

2 am instead. ASUH's position on this is that we are grateful for this compromise. Do you mind elaborating on Interim Chancellor's goal to create a 24/5 study space?

President Dela Cruz While they have this proposed change to take effect on October 1st, President Lassner

also mentioned that UH Administration will be working on a plan to establish/ensure a 24/5 space for students to study. In his email, he talked about looking into better places on campus and identifying what could be a 24/5 space that has access to food, as well as

possibly having just the first floor of Sinclair Library open.

SAL Chen I'd just like on the minutes that we will be confirming with them to make sure that their

office does follow through on that with a timeline, etc. so we know what page they are on

and we have open communication with the administration.

President Dela Cruz Yes, the ASUH will be following up with administration to ensure that there is student

representation involved with this plan to work on a 24/5 space. There has been an update sent to the student body so you should have gotten an update. There has been an update posted on Facebook and I'm working on replying to the testifiers with the same update. Thank you to the committee and the Senate for spreading the word on the issue and garnering student testimony! We got a lot of testimony and a lot of students involved. I hope we can continue doing this in the other initiatives we have through the year.

a. Senate Resolution 01-18: In recognition of the University of Hawai'i at Mānoa's College Rankings

i. SCR 11-18

SAL Leval Move to accept SCR 11-18.

SAL Chen Second.

SAL Leval Move to correct all grammatical, typographical, formatting, and Hawaiian diacritical

mark errors.

SAL Chen Second.

Motion carries.

Treasurer Hinshaw Could the introducer please clarify under comments/recommendations: "To insert a BE

IT FURTHER RESOLVED..."

SAL Leval We'll get to this later, but the original "BE IT FURTHER RESOLVED..." statement

stated that the ASUH commends the administration. The resolution is about commending the rise in rankings, so the committee felt that the BE IT RESOLVED statement should relate directly to the report itself, and if we want to be more general and commend the UH Administration, it would be better as a BE IT FURTHER RESOLVED statement.

Treasurer Hinshaw Regarding the recommendations, how does this contradict what we wrote in the Sinclair

resolution? It's not stating that UH is a horrible school and shouldn't be commended for

its achievements.

SAL Leval The BE IT RESOLVED statement of the resolution says that we are commending the

University of Hawai'i at Mānoa for their educational effectiveness, but in the Sinclair resolution, we specifically state that we are disappointed with the UH Administration's management and effectiveness. So, the committee has suggested that it is okay to commend the UH Administration and give credit where credit is due, but we recommend that that be done in ways and using language that is not contrary to UH's stance in other

legislation.

Motion carries.

ii. SR 01-18

SAL Chen Move to accept SR 01-18.

SAL Leval Second.

Senator Ng This resolution is commend UH's rise in its ranking based on criteria. It's important to

potential students to see how UH is improving its academics.

Treasurer Hinshaw Can we discuss why the BE IT RESOLVED statement should be changed?

SAL Leval I'll just reiterate the committee's consensus. It is okay to give credit where credit is due

in general words, but that should be done as a BE IT FURTHER RESOLVED statement, but the BE IT RESOLVED statement should be explicitly focused on the rankings itself. The committee also recommended that the BE IT FURTHER RESOLVED statement

should not use words that contradict ASUH's other stances.

SAL Chen I personally don't see a contradiction because I see academic achievement as student

achievement. I see that our Sinclair resolution is based on the administration and their

lack of information to the student. I see it as two different things.

Senator Ng I agree with her. Although the Sinclair issue is a big issue, this resolution is focused on

the overall university. We can't say that the university is bad because of this one issue.

Everything cannot be based off of just Sinclair library.

SAL Lao I disagree with the educational effectiveness statement based off of the actual Times

ranking that Treasurer Hinshaw and I went over. There are subcategories that the overall score is based on, and one of its lowest scores is actually in teaching. What caused the

rise in rank is mostly the citation score and international outlook.

Treasurer Hinshaw I also added suggestions to the resolution.

SAL Chen For the BE IT RESOLVED, we could remove the items we are lacking in, such as what

SAL Lao mentioned.

SAL Leval That was reflected in an amendment in the SCR, "the ASUH commends the University of

Hawai'i at Mānoa for rising six positions in the 2018 Times Higher..."

SAL Leval Could you please go over the added WHEREAS statements?

Treasurer Hinshaw They are just suggestions that I just jotted down continuing off of the WHEREAS

statement.

SAL Chen Should these suggestions be added through a motion?

SAL Leval Is the wording the intended wording?

Treasurer Hinshaw They were done to give a basic idea. It is also fine to change the format. They are here to

address the SCR.

SAL Lao If we start to flesh out these WHEREAS statements, I'd rather go with the SCR's

recommendation to table this.

Advisor Manini If you work on addressing the recommendations in the SCR, it might be ideal to refer it

back to the committee so they can be further discussed there. The resolution would still come back here. If you include score that don't look very good, I think you should also

positively encourage the university to keep improving in those areas.

SAL Leval Advisor Manini, one of the reasons the committee recommended to table this resolution

is we weren't sure how to amend the resolution to make it better. So, we thought that the introducers would have the best hand in amending the resolution and make it more clear and concise. Other than tabling it, would there be a way to send this back to the

introducers in order for them to flesh it out?

Advisor Manini You could table it until the next meeting with the intention that the introducers work on it

and redraft the portions of concern.

SAL Leval Based on that and the recommendation of the committee, I move to table this resolution.

SAL Willis Second.

SAL Lao Advisor Manini also recommended that it could be referred back to the committee. If it is

possible, I would love for the External Affairs committee to see this again as well.

SAL Leval I would prefer the introducers to work on the resolution as opposed to have the External

Affairs Committee work on it because I would not like for us to step on the work that the

introducers have already put into the resolution. Move to amend my motion to table this

resolution until the next meeting.

SAL Chen Second.

Motion carries.

SAL Lao My intention was for it to go back to the introducers, then go back to the External Affairs

Committee.

Advisor Manini Procedurally, you would say send it to the committee, then the committee would take the

time to work with the introducers.

SAL Leval If we decide to send it back to the External Affairs Committee, and we were to meet next

Monday, could the introducers amend the resolution between now and next Monday?

Advisor Manini It is up to them.

SAL Leval Move to amend my motion to send this resolution back to the External Affairs Committee

for further review.

SAL Chen Second.

Motion carries.

Treasurer Hinshaw I think the resolution is clear. We have done this in the past, and the ranking can simply

be added from the source itself. I don't see the need to go into this in further detail.

SAL Leval Based on what the committee discussed, thank you for including the additional

information the committee requested. With the new development, I think it would be best

to send it to the External Affairs Committee to polish it.

SAL Lao Move to call the question.

Louie Anthony Sicorsicon Aloha, my name is Louie Anthony. I'm one of 40 members of the ACE program, which

caters to about 400-500 freshmen at the University. We have about 50 learning

communities tailored to different majors that our students are interested in not just from our local population, but from the continental US as well. The purpose is to ask for funding from ASUH to fund our end of the year activity - the ACE Bash. The goal is to provide recognition for our freshmen who are in the process of completing their first semester here. As a program, we are big on keeping our students here, and we believe that by creating students that are engaged and active on campus, as well as creating opportunities where they are celebrated, the ACE Bash is one thing where we can help students feel engaged. We are asking for \$4000 for our ACE Bash event, for the most part food and supplies. We are in the process of completely securing our vendor and

menu options, as well as decorations and marketing. We hope our student government

can help support our program.

Senator Finau I pulled up the Senate Act from last year that funded the ACE Bash, so I'm curious why

the food/supplies increased by \$500.

President Dela Cruz There has been an increase in the amount of freshman involved and the learning

communities, so the increase is due to the increased amount of participation.

Senator Finau Another thing is that the food line item would have to be super-quoted. Move to change

the Food line item to \$2499.99, and have the total reflect the changes.

SAL Chen Second.

SAL Leval Would this amount be enough for 400-500 students? It is approximately \$5 per person.

Louie Anthony Sicorsicon We are not planning on providing a full meal, but pupus and refreshments such as tacos

and churros. We are going with a Day of the Dead theme.

SAL Chen Are there any other fundraising efforts or funding sources?

Louie Anthony Sicorsicon We are working at the different stands where they are offering us to work. Right now,

with only 40 mentors and 400-500 students, it is a high number that we are trying to reach. We have gone to different fundraising opportunities, but since we are not a

nonprofit entity, they would not allow us to fundraise.

Motion carries.

Senator Finau Advisor Manini, is there a fee for the special event?

Advisor Manini I don't think there's a fee for it, but I also don't think that groups such as this understand

that the Department of Health is now cracking down on what we feed people on this campus. I don't think it's also realistic that you guys are funding everything. It should be noted for your program that there is Department of Health paperwork for special events. The Department of Health has been coming to campus to double check that events have

the appropriate paperwork.

SAL Chen In that case, move to change Section III to "ASUH shall be recognized as a co-sponsor of

this event."

Senator Finau Second.

Motion carries.

Senator Utashiro Are all the participants full-time undergraduate students?

Louie Anthony Sicorsicon Yes.

SAL Chen Could you clarify the decorations, as mentioned in the SCR?

Louie Anthony Sicorsicon We are going with a Day of the Dead theme. We wanted to keep this frugal assuming that

we might not get the full amount. The decorations committee hasn't completely finalized the decorations. Our centerpieces would be comprised of handmade stuff, we would have streamers, banners, balloons, and goody bags. We are also looking at getting wall-lighting. Each of the wall-lights will be about \$50, but this is still not finalized until we

have something provided for us.

SAL Lao I think that \$750 is a lot to decorate the ballroom.

Louie Anthony Sicorsicon Right now, it is safer for us to go with a more frugal budget because we do not know the

funding we will have.

Senator Finau I think this is a good number, based off of the decorations we have done in the past. I

think this is the same amount we allocated last year as well.

Senator Finau Move to call the question.

SAL Chen Second.
