#### c) Covid-19 Distance Learning

President Li

As you have all heard, colleges across the nation are closing their doors in favor of distance learning. Right now at UH Manoa, there has not been any moves to move to a full campus distance learning procedure. But individual departments have been told they are able to decide to do so if they want to. I know UH is monitoring the situation and will send out an email regarding distance learning. While this is happening I want to make sure students are being heard, so students are not caught in the shorthand of this. Also, a lot of students need employment to pay for tuition and some need the school's health

insurance. I have sent an email to Lyons and Lassener about making sure ASUH is included in any discussions moving forward to make sure student perspectives are not lost. If you are traveling please stay healthy. In regards to our meetings, I think that is a topic I want to open up to the executive committee about how we would proceed if the campus goes to distance learning.

Advisor Manini If the campus goes for distance learning, there is still instruction. So you guys could still

meet. If you guys think a meeting would be dangerous, then set some standards. Like if people get sick, for them not to come. Unless the administration says you cannot come to

campus at all, you should try to figure something out.

SAL Manabe You could just suspend the meeting rules that mandate that we have to have it on campus

so we can livestream it instead, then we can still have the meeting and have it accessible

to everybody.

Vice President Rafid However, you have to start the meeting in person to suspend the meeting.

Advisor Manini I would say try to still meet in person.

President Li How do you guys feel about meeting in person for the March 25th meeting?

Advisor Manini You have to understand, it isn't just your rules, it comes from Roberts, in terms of

meetings.

President Li Are there any strong feelings regarding the current meeting?

SAL Kim I just had family visit from Korea, and I had to self isolate, but I am all good. But I'm just

concerned about how many students have international ties.

Advisor Manini I think your concern is a desire to join meetings electronically, that somehow if someone

is sick or has to self isolate, there be an option for that person may still participate. You guys could technically, by a <sup>2</sup>/<sub>3</sub> vote, if for some reason due to this current virus that if anybody who can qualify for making quorum, has to stay home, that you guys are

willing to have them join the meeting, count as quorum and participate.

President Li what motion would that be?

Advisor Manini "motion to suspend the rules to allow for video engagement in ASUH meetings and

having that count to meet quorum requirements, be able to vote through distance

mechanisms if necessary due to COVID-19."

Vice President Rafid Could we do it prior to the meeting?

Advisor Manini I was you guys, I would do a vote now to allow it while the virus is here. I doubt any of

your constituents would file a case against you.

President Li Advisor Manini is saying we should pass a motion saying from here on out that we

That is 29%, so we could still spend about \$12,000 for advertisement. So for cash awards for this year so far, 113 people have been awarded and only 66 were actually processed. I have asked office staff to send me all of the emails from the ticketing booth and counted

them, and only 66 have been processed. So I will talk to Healani.
