Senator Wang I'd like to pose some concerns about how this will affect stipends because some senators

are already having a difficult time attending the meetings we have. If they will be a requirement, some people may not be able to make those requirements because of school

or work.

Chairperson Lao Last year, we proposed that office hours be a proceeding, so each hour of your office

hours would count as one proceeding, and if you obtained a certain percentage of your proceedings you would receive your stipend. It may be harder to obtain your stipend, but for some people this may help since they may not be able to attend a meeting, but can use

their office hours to meet the required percentage of proceedings.

VP Dela Cruz I see office hours as something that we can encourage people to do this year, and not

make it mandatory. This was what we did last year, and majority of us fulfilled our office hours. Some of us may not be committed to it as much, since other things such as school, work or meetings may come up, so I like the idea of having some flexibility but still being able to do office hours. I don't think it should be mandated through a rule revision

since the next senate might not want to have office hours.

Senator Wang Will there need to be a rule revision to implement that?

Chairperson Lao I don't see a need for that if there won't be any consequences to not attending office

hours.

Advisor Manini I would recommend you and your committee members have an informal conversation or

committee meeting specifically to discuss this matter so senate members can come and talk about this item so you can discuss ideas and whether it should be formalized in a rule

or not.

Chairperson Lao My intent was to see who's interested in office hours for now. It's been brought to my

attention that there has been some non-compliance with Rule 18-41. Turning in your minutes is an all-or-nothing thing. We'll be looking into a rule revision, but I just wanted

to let you guys know for now that you may not be getting your stipends.
