why you're requesting funding. The decision is ultimately up to us.

Advisor Manini I already shared this with caucus, but I want to share this here because it's not all the time

> that ASUH members can positively make a change across the UH system that can impact other students. I don't know if you all remember former Presidents, Kelly Zakimi and

Stephen Nishihara, but they served a couple years back. Around the time that they were serving as Presidents, one after the other, Kelly had been Stephen's Vice President at the time when he was President. There was an issue where financial aid recipients could not get paid their stipends and if they got the award for their service and we tried to pay, the financial aid office would adjust their award packet and they would lose their award or they would have to pay money back to financial aid. Those two Presidents came to the SLD Office and made their compelling argument that something needed to be done to fix this. They knew that people across the system were dealing with the same problem. Over the process of a few years, we came up with a temporary solution, which was allowing ASUH members to either pick the bookstore gift card or the cash award. If people in this situation were to pick the gift card, they would still be able to get their recognition; if not, they would be penalized. Fortunately, this past academic year the Associate Vice President's Office worked with remedying this problem so in May of this year, we got notice that from here on out we will be using the 7244 line item in the budget. If CSOs want to provide some type of scholarship rather than an award for service, they can still budget from the 6500 line item if they so choose. If it weren't for ASUH Mānoa students saying that something needs to be done so we don't penalize financial aid recipients for being involved with CSOs then we wouldn't have had the change. I just got a call from Hilo that this still has not been implemented, so I spoke with the advisors so that those students can get their awards for service as well. This is all because of you guys and the work that you do. I know it's challenging sometimes, but ultimately there's good things that come out of this body. Keep up the good work. This was already implemented here at UH Manoa?

We implemented this in the Spring and when I went back to caucus this year, most of the

campuses said it was implemented for them. Only two campuses said it wasn't. Yes, it is

I'm just asking because I recently had my financial aid package cut, but because I was receiving too many outside scholarships. I was just wondering if this played a factor into
