Ad-Hoc Committee Sign-ups *President Albano*

Just a couple of things. I sent out the ad-hoc committee sign ups this past weekend. Again I do not want ASUH business to be super stressful, so if you don't want to be part of an ad-hoc committee you don't need to. It's up to you.

UHM Reorganization in Post-Pandemic Hawai'i *President Albano*

The next thing I want to talk about is the reorganization. We talked about it last week and we were able to have Dr. Ashley Maynard come as a guest speaker. Which I think was a fantastic discussion. I hope that gave everyone an understanding of what's happening. I did want to give a couple of updates.

First of all, if you click on the agenda link, you'll see formal consultation. As of Monday, I received an email from the administration officially initiating formal consultation with ASUH regarding the reorganization and recommendations. There's a letter formally stating that the administration is formally reaching out to ASUH to provide feedback on the recommendations. Basically, it discusses the budget crisis that the University finds itself in and provides rationale for why the recommendations are being made. As the Executive Committee, it's important that we are vigilant about these changes.

I want to highlight that there is no intention to eliminate field faculty and staff positions. Further positions may, however, be redescribed for better needs for the University. It looks like there is no intention to eliminate positions, but the ones that might be eliminated are currently vacant.

Please feel free to take some time to look through this. This kind of ties in what I will talk about later. I do have a meeting with Provost Bruno next week Tuesday, so if anyone has any questions that I can ask him or if there are any particular issues of concern that you would like me to bring up please let me know. We have a little bit of time because its next week Tuesday.

Regarding implementation of plans, it says the affected date of the budget changes will be upon the approval of the president. “We are hopeful that we can work collaboratively with all bargaining unit representatives to conclude consultation by November, with approval and implementation by the start of Spring 2021 in order to place the campus in a better position to respond to the financial crisis.” When I meet with Provost Bruno next Tuesday, I will discuss more deeply about the process of formal consultation.

Regarding the reorganization ad-hoc committee meeting, I thought it would be best considering it’s a pretty urgent situation that we have a meeting sometime this week. To those who have signed up to be on the committee, we’re going to have a meeting tomorrow at six p.m. via zoom. If you didn’t sign up yet and you want to be part of this ad-hoc committee and would like to attend, can you please let me know now or after the meeting? Does anyone want me to send you the zoom information for the meeting?

Advisor Manini

Unfortunately, I missed your report earlier when you talked about the consultation for the reorg. In preparation for that, when I had seen the email that you shared with myself and Vice President Kim earlier this week when you received it, what I wanted to say is that I do hope that because it's complicated and it's coming up fast, and we know that there are a lot of folks like stakeholders, graduate students, faculty, etc. that have opinions on this issue as

well as have been working on this issue. Instead of recreating the wheel and working in isolation, and I know that some of you have already been in contact with others who are very interested in this because the programs are being impacted and that those will eventually impact undergraduate students as well. I just want to encourage you all, whoever may be working on this to stay in contact with folks from these other stakeholder groups because why recreate the wheel? They are already writing out arguments for or against this, and I believe you will probably as a Senate be concerned for undergraduate students and impacts on undergraduate students. Instead of leading work in isolation and all of that on your own, you may as well look at what these other groups have put together and think about them for what is beneficial for undergraduate students. Then add on anything else that you want to add on in terms of your discussion on this topic. That is all that I was thinking separate from you all when I had seen that you were approached for consultation. I also wanted to say that the time period is usually pretty tight when formal consultation occurs. Never before has the University applied the executive policy M3101 which does consultation with the student organizations meaning ASUH and GSO the way that it has with the faculty senate. The faculty senate was included on M3101 for years and Landon and I talked a lot, and he discussed M3101 and advocated with the Provost for ASUH to be included in the M3101 consultation that the Mānoa faculty senate receives. I believe that is why you guys are getting this this year. I think that's great. It's Landon who advocated for that appropriately, so take advantage of the opportunity that you have to be able to engage in the formal consultation process. Thanks a lot for giving me the opportunity to say this.

President Albano

Thank you so much, Advisor Manini. Since we decided to create the ad-hoc committee, I felt it was best that we preliminary had a meeting to discuss responses. We are going to have a preliminary meeting tomorrow at six pm.m for those who signed up to be part of this ad-hoc committee. I'd be happy to send you the Zoom link if you are able to attend.
