President Zakimi It is in our rules that our constituents are to testify first.

Shiina Losciur Hi Everyone I am here to testify for Senate Resolution 06-16 and Susan asked me to

testify. I was student who was affected by the protocol that is currently in placed or not be one and found out from a friend through Facebook that unfortunately I didn't feel that it was the right way to do it. It's very hard to find a protocol. We treat every situation differently and we have lots of examples that other university use. Basically, we are researching and proposing for a new way to not only honor, notify students and anyone in the university community of anyone passing away. But, to honor them or provide support for those left behind that is clear and not just left behind and unaware of what to do or

what do in situation like this. Are there any questions?

Susan Schultz Hello, thank you for having me. I am a professor at English department. Reason that I am

here is last year, I walked into a classroom and confronted by a severely traumatized student who witnessed a fall of a student to his death. I was completely unaware that there was a tragedy on campus. I was taken aback on what to do with this student that was traumatized. I took him to the counseling center and did not tell him to say he was in a "immediate crisis" and so that he needed to wait several days for an appointment. That started my interest of creating a protocol surrounding student deaths around campus. Such protocol would take everyone involved from our end, upper admin, process and dealing with a student who has died on campus. Whether that is a natural death or suicide. To know that there are suicides that occur on campus, we should better provide suicide preventions on campus as well as provide better advertising for the counseling center and

its hours, it functions and why you or a friend want to or need to go to the counseling center. I have with me several packets that include a petition that was signed by over 300 people and also includes the best protocol I have seen from the College of William and Mary in Virginia, its over 20 pages long and this takes everyone in every process to be involved in the process. There are also examples of letters sent out to the entire community by the College of William and Mary. There are also another wonderful protocols from the University of California Berkeley, which you can find online. Also, one more thing UH West Oahu sent out one of their frequently mental health moments which announces to the community the Counseling Center is there and also tells them on how to deal with mental health issues. I also have one thing that is launched against my argument which is often talked about if you talk about suicide there are more suicides. So I have something from the national institute of mental health, which advises you what to say on not how to create suicide contingent and what wrong thing not to say. Any questions?

So I just met or spoke with the Dean of Student Affairs Mike Kaptik. They have a protocol where they do not just release it to people.

Susan Schultz

The protocol that I was sent is just long and inaccurate to the law. You will be rivaled if you do CPR on someone who suffered from a traumatic injury and that is not legal because there is a good samaritan law in the state. The protocol they have is insufficient.

money. But, I think that \$2000 is still a lot for wristbands and sweatbands. I think we

need to reevaluate the amount

Dr. Ideta Life and death is not upgraded does not get bigger then that. Dean Kaptik and I are two of

the people that respond to the emergency on campus 24/7. Things happen in the middle of night, we get deployed as well as Director of Counseling Center, Dr. Tanouye. We remain on campus until it has simmered down. So there are a lot things we have to do if a death or tragedy occurs. There are multiple things that we have to do. We also look into the desires of the family, we respect their decisions of not having the tragedy be disclosed to the public. For the second be it resolved being moved as the last statement. I was a little confused when it says we "are unable to obtain consent from the family being disclosed to the community." If we don't have permission from the family, then we can't inform the campus. This is the smaller details that we are concerned. We current have protocols to let the campus community know when there has been an incident. What we do now practice, is the respected classes that the student is enrolled in now let them if they are working on campus, housing and more. We do not practice of letting everyone on campus knowing the 25000 students. This for variability of reasons to ensure that the notices does not trigger

others. We are also trying to balance the privacy of the deceased. We also deal with immediate information that happens sometimes we do not have the details until later. We have peer 9 institutions, these are similar practices to five of them. None of them require to send a mass email to the whole campus. We would ask you to consider that every time there is a tragedy on campus, it puts us on a particular spot of talking to the family and negotiating with what they want, trying to get them here and figuring out the services. We here tragedies through social medias and we go back to the information. The timeliness for the notice, we need to go back and look into

Dean Kaptik

When we looked into other school, like UCLA, U. Wisconsin and Chicago, schools similar to our size. We see death protocols are online but none of them benchmark or peer are mandating going to an group of 25 or thousands. William and Mary is doing whats important to their campus. They have 6000 undergraduates and and 12000 graduate students. This is a different environment. Kitchner talks about not doing any harm. We as administration is trying to do what is best for the campus and reducing, being targeted and focused from sending out the communication. Dealing with issues with random emails causes them struggles and were not prepared for. We trying to look at that every situation is unique and this allows us that flexibility

Dr. Ideta

Whatever you pass, please work with us. We had a conversations with the Vice President of William and Marry College and they use their protocols to be used as guidelines not a checklist.. Each of our lives our unique. Please help us be as flexible as possible. As we Advertise more about the wonderful services of the Counseling Center we need more resources for them.
