ii. SB 1-17: Establishing the ASUH Budget for the Fiscal Year 2017

Treasurer Hinshaw This bill is for our budget for FY 2017. From what Advisor Manini and I discussed, our

market portfolio is projected to not do as well. Since our budget is based 5% off our portfolio, we are running of less than the previous senate. For Part III A1, we increased the allocation because we increased Healani's salary. Our budget is \$22,825 less than the previous budget. In UAA, we changed the wording to Fiscal Year instead of Fall and Spring. We also changed the wording in Part III C1 so that the assistance of UH Faculty

or staff is only needed when deemed appropriate by UAA.

Senator Lao Where did we get the enrollment project in Section A?

Advisor Manini We get the number out of the Fiscal Office. They do the project numbers for all of the

CSOs.

leave during the summer. If you want to make changes, I suggest that you table this since you would need to double check that all the numbers that are affected by Section B3 throughout the budget are correct and reflect the changes. This is a rough estimate so we

have enough money.
