VI. OPEN FORUM

A. Cash awards

a. Pres Watson: will be given out not pending the budget; will be using funds; will need to get through prior FY cash awards; look through July and August as well as Sep

B. Committee meeting

- a. Pres Watson: Talking to staff senate and asked about any interest in having the president or provost come in for a meeting; would like to have senate to work with president towards not pushing for private-public partnerships (UHM contracting private organizations to create housing for UHM; incredibly overpriced); President Hensel agreeable to having more P3 instances/not much interest in self operated housing
- b. VP Ziadeh: Can they put money from P3 housing to self operated housing?
- c. Pres Watson: She could but it's cheaper for president to do P3; advocate for her to get more state funding; work with possibly any other organizations to persuade president against these P3
- d. VP Ziadeh: they have prioritized freshman which causes housing crisis; they have not renovated the buildings
- e. Pres Watson: make sure we bring in solutions, no inclusion of P3 agenda
- f. Advisor Healani: we need a reso
- g. Pres Watson: meeting w/ Pres and have testimony with people in rise and Haukani; unreliable and more expensive for students; no sense of community
- h. Advisor Bonny: as you prepare yourself to speak with staff, need to have a planning meeting to have open discussion; planning meetings will help with pros and cons with self-op and P3

C. Interest Scooping of CSOs

a. Pres Watson: UH admin will take our interest yearly if there is money sitting in our accounts; policy implemented last year w/ out our consent; detrimental to sibling organizations; takes away their money and goes into presidents account
