A. <u>SB 04-26</u>

- a. allocating funding for SFJP open mic event
- b. Pres Watson: any idea what were doing for promotional
- c. VP Ziadeh: mostly just flyers and banners
- d. Pres Watson: you could do ground stakes
- e. Advisor Bonny: SFJP is not a RIO so using the 3325232 as a co-sponsor of the event is best if you all want to support this. The provision should specify ASUH as a co-sponsor; can be amended in finance; the purpose should be about the event itself
