This issue is a catastrophe and is extremely pressing. I shared all this information in my testimony because I wanted to emphasize how vital it is for this Senate to take a position and use their voice to fight to protect our water, aquifer, communities, and people of the island. As a former senator of ASUH, I know how powerful it is that this body takes a stance and utilizes its resources to influence positions because everyone here is the lifeblood of the university but also a part of the community and we know that the UH system is intricately tied to the systems that shape the community beyond this campus and the university plays a role in this water crisis.

President Kim

We will also go through the written testimony by Donna Ojiri who is a dietication with Manoa Dining Services regarding senate bill regarding implementing meatless Mondays.

Donna Ojiri's testimony does not support the resolution as written and recommends that further deliberation and advising be held to increase plant-based food consumption at resident dining halls.

Advisor Manini

I'm wondering if the introducers or the committee that read the resolution reached out to do any type of consultations with those who oversee these programs to see how many students are meat-eaters vs non-meat eaters. I can just leave it out there and once we get to the legislation because of this testimony being here at this point in the meeting

In his report, he says he will be sending a document to all chairs and vice chairs that have asked about any bills for legislation on the status of their documents to see if they have a draft version, codified version, uploaded to the ASUH website. Many documents were passed in the Senate, and he will need help from the respective committees to have them codified and uploaded onto the ASUH website. And then per Advisor Manini's email, meeting notices have to be posted two days in advance to the scheduled meeting. Charis and vice chairs, you are responsible for letting office staff know and putting in a work request to get it posted to the ASUH website and on the bulletin board at Campus Center. For example, if you put in a meeting request Sunday night, and your meeting is the following Tuesday, you did not give office staff ample time to post it.

President Kim

Please send those meeting notices as soon as possible. I will work with office staff to make it so that we can link our shared ASUH calendar to something on the website, so it publishes on the website automatically.

Advisor Manini

I believe earlier this semester, Advisor Sonada-Pale asked that meeting notices get sent 72 business hours before the meeting, so it gives the office staff time to get it adequately posted before the 48 hour deadline. Please follow up to see that it was done, especially if you have action items on your agenda.

We are currently being audited by the affirm known as Acuity which is an external firm. They are auditing fiscal years 2021, 2020, and 2019. Fiscal years run from June to July of the next year. So Fall 2021 was technically already in fiscal year 2022. We start fiscal year 2023 on July 1 of this year. Acuity is doing three previous years of auditing, and part of it is we have to give them an MDNA.

Part of it is asking us to highlight some accomplishments of the previous senate. Obviously the previous senate is gone, so we are the ones to tell them. I think I need to get students to give me input as to what you feel are the highlights of the previous senate, so please let me know if any of you want to look at the past legislation. I have opened it up to the President and the Treasurer because they were involved with the audit, but if any of the rest of you have time this week, and you want to look at legislation who ended June, 30 2021 and say hey this is a highlight that we shouldn't miss as students and put in our write up, then please let me know.

Students in ASUH are actually having a say in the past and current years. Same will be with this current year of this and the future you know will get us what was the highlight of the current 2023 school year and I would want students to have a say. Like I might put stuff in or raise a question and say "well isn't this something great too?" like I think I told Alyssa when we were in passing one night I didn't you guys start the textbook awards like towards the tail end of 21? I can't remember exactly, but I think you all wanted to start that to try to meet students' needs beyond just the scholarship program. So if that was started you know in spring 21 that might be something that ASUH should feel proud about for adding on to offerings to students hectare students have been dealing with COVID and everything else, but I do want you to give some time and thought to it if any of you were interested Tell President Kim know or treasurer Saari or myself that you want to give some input on this if you really want to get it done this week.

The other thing is in regards to the investments and long-range planning committee, one of the most important jobs of the committee is making sure that ASUH gets the quarterly reports from the investment firm that we work with named Greystone.

It is the Board of Regents policy that we get that on a quarterly basis. I do not believe it has been done yet for October or for December, so out of major concern that it has not been done, I wrote to the the firm and asked them to send a paper trail at least because normally the meetings are scheduled in the committee and in the financial advisor comes and presents the report to the ASUH committee and then if you have questions, you can ask questions and then the paper documents are filed away for evidence that we've done our due diligence. But those things

were not done, and out of sheer concern for ASUH, I just went ahead and asked them to send me the paper versions at least so we can file it away, and I did tell them that the ASUH committee might come later and ask for a meeting then at that point please go ahead and schedule the meeting with the ASUH committee and then work with them on presenting and then answering any questions that they have.

So at this point as of now I believe earlier this week those are all filed with the office. I sent them to Healani and I told her to file it at the office, and so for ILRP and any of you who are interested in those reports, they are filed at the office but it does not take the place of the committee meeting. You have to schedule a meeting to catch up on the quarterly reports.

With regards to student fees there's many different conversations going on about mandatory student fee, and so I've been in conversations with students across different across different CSOs and also work directly with CCV, so all of those are my responsibility are my position in student life and development, so I do have conversations with students across CSOs from time to time. CSOs if you don't know are charter student organizations and ASUH is one of them and so there is an executive policy floating that could affect student fees and Jungha and Alyssa are aware of that policy. We've come to learn over the past semester that there were students in certain programs that are under the Outreach College that were able to access U pass and able to access the warrior recreation center when they are not paying fees, and we don't know why they're not paying fees because they should be paying fees based on the mandatory fee policy.

And so when we became aware that those access points were shut off. However, we are also going to be looking into why there are students being allowed to be in programs where their fees are being somehow waived for them, so we're trying to figure out at this point if it involves any undergraduate students. We know that it involves graduate students.

We are in contact with GSO and SAPFB and CCV because we know those organizations are being impacted. I don't know at this point if ASUH is being impacted. And so if I find out that ASUH is not collecting all of your five dollar fees because of some administrative issue that's going on then I'm going to contact the president, the vice president, and the treasurer and let them know so that hopefully we can get someone from ASU each also involved in discussions we're having across CSO.

Advisor Manini All of these entities would consider whether or not they could do it or not

and if they couldn't, they wouldn't. I know for sure that for the plastic water bottles, Eddie told me that he's been asking our food service providers to look at boxed water because places where there is a social consciousness about plastic bottles, that they moved towards using boxed water instead. I know that there are open minds to see if there is a possibility and students have been artiuling this for years and years. The last time it came up it was a huge drama in the senate and it didn't pass and people left the meeting crying because they were passionate about the initiative. There are also employees who have been thinking about it also. If ASUH does believe in it, then the people who work at UH, they would see how much of the initiative they can and can't do and be in

communication with the student leaders to see where they can make

Our plan is to have times of 2.5 hours each, that would be 30 people per day, we would be serving a total of 60 people

and oplan to hold it on a larger scale in the future.

Advisor Manini If the senate approves this and you do your ads, i recommend you say that

the first 60 people will get the headshot and if there's a lot of interest, the senate can always reconsider another bill. GSO has less than half your number of constituents so I would think you would have more people interested in your event. Just make sure to be clear with the instructions.

Senator Stephens GSO did a research on the average rate of photographers, which was

70-100 per hour and this will be around 5 hours so I made the price point

based on that.

President Kim It is always a good idea to estimate the amount of money being spent per

student. With the estimate of how many students, how much are we

spending per student?

per student.

Vice President Renteria This bill is similar to past bills regarding the textbook giveaway, this will

be held in the spring 2022 semester. There is a difference in the appropriations section. In the past, the committee has awarded 50

students, but in an effort to make the winner selection process, we casted a wider net and then form those students, well keep it to 2 rounds. Last semester, we did 3 rounds and that took us to the end of the semester, which we are avoiding. So now there can be 100 people and the reward amount is still the same.
