**SENATE ACT 26-18**

**FUNDING FOR THE UHCHOIRS**

**BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:**

**SECTION I. PURPOSE**

The UHChoirs are requesting \$2450.00 for UHChoirs uniforms. These uniforms would be aloha shirts used by the UH Chamber Singers and Voices of Aloha in concerts and tours, including our upcoming trip to Spain this summer. Previously, students would purchase new shirts every semester for \$30. We are instead proposing to use the allotted money to buy a bulk order of shirts that students would be given at the beginning of the semester. They would be held accountable for their shirts for the duration of their time (akin to using a football jersey). The students would sign contracts acknowledging that the shirts are not their own, and that they must return it at the end of their time with the UHChoirs.

**SECTION II. APPROPRIATIONS**

A total of \$2,450.00 shall be appropriated from Senate Account 3325232 (University Programs, Services, and Support).

**SECTION III. PROVISIONS**

In accordance to the ASUH Senate Rule 27-1(h), the non-ASUH organization that may be funded is required to submit a follow up report on the proposed event or program. The follow up report shall include information regarding finances if any appropriations had been made in this measure to said organization. ASUH shall be recognized as co-funding the events and on all advertising with the phrase "partially funded by ASUH". Partially funding of said events shall not constitute co-sponsorship by ASUH. ASUH neither implies nor accepts any liability as a result of partially funding said events.

**SECTION IV.** Any unexpected or unencumbered balance of any appropriation of this act as of the close of business on May 02, 2018 shall lapse into Senate Account 3325232.

**SECTION V.** The Treasurer is authorized to draw upon said account.

SECTION IV. This act shall take effect upon approval by the Senate, pending on the approval of the ASUH Budget by all required signatories.
