1. Dr. Michael Bruno, Vice Chancellor for Research & Interim Vice Chancellor for Academic Affairs Office of the Vice Chancellor for Research, Office of the Vice Chancellor for Academic Affairs (OVCR, OVCAA)

Dr. Michael Bruno

We are building out a new undergraduate research office and in the process of hiring people right now. I know there are different opportunities out there via federal, medical school and other things. I hope to provide undergraduate students to get stipends, low cost dorming over the summer so that they could do research. We are hoping to get a website up that has information about research and where you can get connected with faculty. On the academic side and regarding the legislature, we are tearing down the Sinclair library and making it into a student success center. If that becomes a reality you guys will be part of the early discussions of that, looking into collaboration spaces or having places for students to take naps, things like that. We are looking at the retention programs, how we distribute scholarships, and having more things in general on campus for our students.

Senator Manabe

It was mentioned that there would be more research opportunities for undergraduate students but that is more for the STEM field. Would there be opportunities for other non-stem students?

Dr. Michael Bruno

For me research is about moving your field forward and that could be in the performing arts, languages and literature, it could be biology. We talked about cultivating a capstone experience for students across all programs. When we say research we're talking scholarships and that includes all study fields.

SAL Lao Dr. Michael Bruno What are your thoughts about the reorganization posed by the Chancellor Lassner? He appointed a smaller group a while ago, yesterday we had our second meeting discussion the details and there are two primary requirements for that. One is to bring research and education together, we are very unusual about that here. We have academic units and research units, as if academic units don't do research and vice versa. The other requirement is to ensure that student success, primarily new graduate students, that they are drawn together and made stronger. On the academic side we are talking about making academic advising stronger, international programs, and maybe having one home for all the programs. The way in which we register, classes and classrooms, they all could be made better. We talk about how you have to apply to graduate, why do we need that? We have a system where we know you have enough credits for graduation so why don't we just tell you? I can tell you that there is a lot of discussion about general education, like in any university. We are soon to have a external committee to review the general education programs to see if they are accomplishing goals and see what other universities are doing. We will take a look at the report, and share it on the website as well.

SAL Leval

What is your stance and the administration's opinion on the concerns over the FQ hallmark and the class cap at 30 students, and your opinion on how to fix that?

Dr. Michael Bruno

I'd like to see more evidence for the 30 and I am not convinced that smaller class sizes are beneficial to students, we need better teachers and other things. We have to teach teachers how to teach. We were having a big problem in calculus at the other university I was a dean at. We went in and re-engineered calculus, put more things on the website with tutorials, and the failure rate dropped dramatically. We brought in an external person for math right now, and I am anxious for chemistry and others to follow suit. Right now our challenge is budget because it turns out we might double the numbers of sections. My opinion is that I am not convinced on smaller class making for better student success, we need better teachers because students learn differently from students 30 years ago. Just because you get handed a PhD degree doesn't automatically mean you'll be a great teacher.

Senator Manabe

Would the University possibly create more general education classes specialized for certain majors?

Dr. Michael Bruno

I expect that it will be something we'll hear about from the external committee. The intent is that you graduate with some foundation of liberal arts. We all know that soon after you leave here you will be doing unexpected things and interacting with people who don't have the same background as you.

Athletics

David Matlin I am the athletic director, and thank you for inviting us. From the bigger picture we want

to create a better experience for students. We agreed to take on the responsibility because

we felt we could do it with the staff that we have.

Joe Matsunaga We had this opportunity with the student athletic fee, as a win win for students and

athletics. We believe that students contribute to the fan experience so we want more students at the events. Communication to students have always been hard because we have to send emails, and we see this as something that could help students beyond the college experience. On the smartphone app that we will create it will increase student engagement and communication. We will utilize part of the 8% funds to hire some undergraduates. SAFC was student ran in the past but the problem is that there is student turnover so it's hard to see things through that would take years. We are going to continue to shrink down the amount for grants. We are on schedule with our timeline to do what we can at the start of the next school year. We are in the testing phases of the SuperFanU app and we don't plan to roll it out until the next school year for the new incoming students. We are working with the bookstore to see if you could get rewards for example, where if you attend a certain amount of events and points you could redeem things at the bookstore. We have a few corporate partners that could provide cash or

prizes.

SAL Lao Going back to the slide comparing the three apps, is that the one time cost for the apps?

This is the annual cost and SuperFanU has the lowest cost one. We can integrate it to our

existed ticketing system, which is important to us.

Treasurer Hinshaw What would you be using the data analytics system for, would it be to provide evidence

that there is a need for the fee increase?

Not to prove the validity of the student athletic fee, although we would love to have that

dialogue to talk about what the fee is for and why it would be needed. This is to address the piece that used to be done by the student athletic fee committee that is no longer done

by them. This is still to benefit the students.

I have worked with ASUH before the student athletic fee was implemented. I understood

why the SAFC was created, it was more a political move more than anything else. The

students already said they don't want it but you still implement it through the

administrative way, they made the compromise for the students to keep 8% of the fee to use it in a manner in how they felt that they want to use it but it also included the need to increase attendance at the games. This body gives grants and SAPFB gives out grants, so it doesn't make sense that you would give out grants. The general student population has said they didn't want the fee but when you still implement it through administrative ways, at least make sure that it benefits the athletic program and students get motivated to

support the program.

We do intend to re-look at the issue of how effective the grant giving is. As you can see Joe Matsunaga

also that we have much less going to the administrative costs and much more going to rewards programs directed to students. We could make it fun and it is important for as

many people to download it as possible.

To increase student engagement in sports there is a lot less mens sports than there is SAL Honda

women's sports. Is that something that the athletic program is looking into? Could there be more co-ed sports maybe? Is it possible for all athletes to not be on scholarship?

We have about 21 programs right now. We have 13-7 and one co-ed. It is federal law and we have to mirror the student population here. It's not about scholarships there are three

prongs to it. There is participation, scholarship, and laundry list to make sure they have the same equipment and coaching. You have to meet the scholarship portion. There just isn't much opportunities for co-ed sports according to the NCA, but I'd have to do some

research on that.

Joe Matsunaga We have about 500 student athletes in our program, some are on scholarships but some

are not, some are on partial scholarships, but we do give that opportunity. About half of

the athletes are paying full tuition.

Jeremy Wong I am speaking from both a faculty and student perspective. We are looking at perpetual

uniform shirts that will last and they can return it at the end of their tenure. Voices of Aloha that comprises of 30-32 singers and account for the differences in sizes. nice to have uniforms. There were problems with things being out of stock, not having the correct print, and it has been hard to get uniforms every year. What we were doing was borrow or have the new members purchase uniforms from previous members but they run into problems of sizes and they do wear out after a while. It's hard to present ourselves in a manner where we could represent the school because we weren't able to get the correct uniforms. What we have been doing was just wearing concert black, to uniform us a whole and as a team. Even that is hard because it might look different in colors, and we would be able to go more out into the public to represent the school.

Senator Li These shirts you said would last about 5-7 years? In the bill it says you would have a

contract. Would the contract mention that the students should it be damaged that specific

students would be responsible for that reimbursement?

Geoffrey Kahapea Jr. The marching band has set uniforms where they don't purchase every season, sign a

contract, and they have a lot of different sizes. If there is any kind of cleaning needed they would take care of that, ensuring they would take care of the uniforms. Marching

band was supported mostly by athletics, but we are not.

Advisor Manini The marching band has come previously to ASUH and got funding in the past.

SAL Honda Our committee reviewed this earlier today and we were wondering if our department

gives your students stipends or funding.

Geoffrey Kahapea Not at the moment. We are starting to create a coral endowment but that is the beginning

stages through the UH. They are in the building stages of the endowment so I am not sure where they are at. Our students still currently need to pay, but we're at 18% of our goal

right now.

Senator Simeona How many shirts were you planning to purchase and are you going according to the

sizing of the students you currently have?

Jeremy Wong About 40 shirts, and we are trying to encompass as many sizes as possible.

In order for ASUH to provide their input on legislation that affects our constituents in a timely

manner, we ask that this resolution be special ordered today.

SAL Leval The purpose of this resolution is to solidify ASUH's priorities as it relates to the Hawai'i

state 2018 legislative session. If you read the resolution you will see ASUH's previous stances regarding issues such as tuition or commitment to veterans, and you'll later see how those stances relate to the stances presented at this legislative session. We are applying this to our advocacy efforts this legislative session to help improve the

undergraduate experience.

Treasurer Hinshaw For the be it resolved statement, I know that in the email you sent there were some

amendments that you wanted to be made. If ASUH did want to make certain amendments to a certain bill that this is general or vague enough that people outside of ASUH who reads something related to OERS sees that ASUH supports it and pass it, despite wanting to add amendments. I feel that the wording of this resolution is a little vague and can be

open to interpretation.

President Dela Cruz This bill does not specify any specific bill. We are reinstating the position that ASUH has

taken before to certain topics, and this will allow our senate to track bills.

SAL Leval The introducers of the resolution made conscious effort to ensure flexibility in regards to

specific pieces of legislation introduced at the capital. The OER bill was one that included language that was conducive to ASUH's exact mission related to OER.

Nevertheless we appreciated the intent of the resolution or bill which was to expand the use of open educational resources at UH Mānoa. The purpose of recognizing that is so that in the future if amendments were made for the bill ASUH could have a say in that. To say that the statements made in this resolution automatically conveys support for a current yet to edited draft of a bill is not right. No bills are mentioned in the resolution. In the email that was sent it says that ASUH supports bills that alleviate the high cost of

In the email that was sent it says that ASUH supports bills that alleviate the high cost of textbooks through open educational resources. There are bills that have to do with OERs,

and in the email the one bill that was mentioned you guys said you wanted to make amendments on it. From how I interpreted the resolution, it sounds like you support the

bill.

President Dela Cruz The statement says offers implementable remedies and implementable could be up for

interpretation by the committees or me, if I'm submitting testimony on behalf of my office as President. Some people may personably think that the OER is not an implementable bill, but this statement just says that we support bills that are

implementable related to OERs.

Advisor Manini If this bill stayed at its current form, would it be implementable since you wanted to add

amendments to the specific OER bill?

SAL Leval Speaking on behalf of myself I don't think the bill in it's current form is implementable.

Senator Li The word implementable is a very flexible word and we might need to create more

stricter definitions in how we support the bill. We support the idea of OERs but the current bill would require amendments. I think we should change the wording so that someone at the legislature doesn't think we support it. We should add somewhere in there

that we support this bill with amendments, in order to make it implementable.

SAL Lao I can kind of see both sides. All the be it resolved parts start with the same five words

"that the ASUH supports bills". Those words could be kind of leading, even though your

intent isn't to say you support those bills.

President Dela Cruz To specify whether or not we support a bill is important because that is what is going

through the legislative session. I hope didn't confuse everyone else regarding that email. It was just to give you guys the bills that we are interested in tracking, it has no intent to identify specific bills that we are targeting. We are reinstating the position that ASUH has

taken before and allow for our senate to continue to submit testimony.

It is up to the senate to write specific resolutions pertaining to that topic. This is a guide for the senate to focus on different topics of interest at the state legislature to advocate.

The reason we kept the language vague is for flexibility. At the state legislature

legislators are able to gut out the content in a bill and put in completely new content. If you notice on their websites you can see that the title is very vague such as "relating to tuition" because they all share the same intent. Although there is an open education bill there is still the chance that legislators might change the content of different bills that

pertain to the different to subjects in this resolution.

SAL Leval Bills of our interest have already been sent to committees and scheduled for hearings.

Everytime we are not there for hearings we are depriving our constituents of being heard. Although the President could submit testimony on behalf of the Office of the President

President Dela Cruz Although the President could submit testimony on behalf of the Office of the President but it doesn't mean that the President represents the entire ASUH. With this resolution

we would formally be able to represent our 10,000 constituents at the state legislature. To clarify this gives the Chair of the External Affairs and President the ability to testify

for bills related to these topics?

President Dela Cruz Yes. If this does not pass and we still do testimony, the testimony would be on behalf of

the individual person.

Advisor Manini My guess is when you all have potentially taken positions on specific issues that it is tied

to specific bills. It is summarizing based on issues, if you tried to use old legislation there might be problems because even though the intent still stands, it was tied to specific bills

in the legislature.

SAL Chen Move to remove "bills that", and references to bills for every 'be it' resolved statement

while maintaining the intention of the 'be it' resolved.

SAL Lao Second.

Senator Li The issue originally was that it is a bit vague so by taking out bills it makes it even more

vague.

SAL Lao This is more so to reinstate the previous position that ASUH has taken so that the current

senate can testify on behalf of its students.

SAL Leval As Jannah said we looked through all 180+ of the introduced bills this legislative session

that related to the University of Hawai'i. We found these to be the most pertinent to us because of our past stances and who we are. The first couple are related to tuition. The first one we would like to mention is House Bill 2089 related to tuition assistance. Basically aims to include retired Hawai'i National Guards for tuition assistance. Right now active military, retired military and active national guard personnel can receive tuition assistance. The second is house bill 2255 relating to college service corp. This bill creates and identifies a Hawai'i service corp which basically puts students in contact with different internships or jobs within the state that is likely to relate to their degree

program. For students who graduate from Hawai'i schools and if they participate in this student corp they are eligible for up to 4 semesters of waived tuition. The bill aims to support the requirements by the government due to low employment and provides relative work experience that correlates well to what the student plans to do with their degree. HB 29 and 2255 are recommended stances to support those, makes tuition more

manageable for students.

Senator Petersen SB 2329 it caps increase of tuition for University of Hawai'i based on the changes of the

household median income, we recommend to support the intent of this. These are about the board of regents and we recommend that we oppose all of them because they are about how the legislature wants to take away power from the BOR, which could affect the student body. SB 2309 would reduce the size of the BOR from 15 to 7. SB 2316 allows the governor to select a regent outside of the list from the advisory committee that selects the board of regents. SB 2317 makes it so that the BOR wouldn't have the only

jurisdiction over the UH management and organizations.

SAL Leval In my opinion the worst one is 2319 because that one does what SB 2316 is, which

allows the governor to pick a reagent that wasn't recommended by the advisory council.

It also cuts the amount of regents from 15 to 7, and also mandates the student regent to be the student body President of the UH Campus.

SAL Chen

President Dela Cruz

How would that work since there is the President for the undergraduates and graduates? In the bill it says it would just rotate. These bills give a lot of power to the governor to pick regents outside of the current process that we have. A lot of qualified students will no longer be able to get the position if the student regent is automatically the student President.

SAL Leval

The next one is SB 2328 is about open educational resources. I was excited at first but they were going about it in a while that ASUH wasn't about OER. Although the legislature recognizes that this saves money for students it mandates in the 2021 school year, it requires that all courses at UH require the use of OERs. If a course does not the have the OER textbook it requires that the instructor of the course make an OER. ASUH is trying to be more collaborative with faculty as opposed to putting a mandate on the books, so we support the intent of bill. The green revolving fund, house bill 1830. Several meetings ago we had Matt Lynch who is working on the ASUH green revolving fund and he said one of the biggest hurdles was that expenditures greater than \$167,000 had to be approved by the state legislature. If you want to make any meaningful changes on campus \$167,000 isn't going to get you far. The proposed bill makes this worse- all expenditures by the fund have to be approved by the state legislature, which is contradictory to ASUH stance on making the green revolving fund more usable and efficient for the University. We recommend to support the intent of the bill but with suggested amendments of striking the line that says that all expenditure must be approved by the state legislature. These are a couple of newer additions to the capital website. HB 2623 regards the UPass, but we are not sure about the stance on this. This bill aims to reduce the cost of attendance at University by completely subsidizing the transportation fee at UH Mānoa and West Oahu. The reason we aren't sure about this one is obviously reducing the cost of attendance is something that we really want here, but this would lump funds from UH Mānoa and West Oahu when their transportation fees were developed in different ways. UH Mānoa's transportation fees was a student led initiative while West Oahu is a administrative mandate. This may take away the negotiating power that UH Mānoa will have. Lastly improving UH which goes along with making campus more convenient, the language in the bill suggests a move towards capital improvement projects to address campus maintenance. HB 2005 will basically allow University of Hawai'i to issue \$100 million in revenue bonds for the purpose of financing infrastructure and maintenance of qualifying capital improvement projects. The easiest way to think of what a bond is that we are authorizing the University of Hawai'i to take out \$100 million of debt credit to go towards these projects that we would like to complete. What makes it a revenue bond is that when the project is proposed the project wouldn't be approved unless there is a demonstrated way that that project could be paid through revenue made by the University.

The payment of bonds will be tied to revenue streams like student fees, tuition, other

entrepreneurial endeavors?

SAL Leval

Years ago students agree that we should take out a \$30 million loan for 30 years and within those 30 years the revenue that would be used to pay would be in part the student fees. We didn't really have a recommended stance please communicate with me and Jaylin about what we should do about that one.
