President Dela Cruz This is the time when the public will be able to give testimony. Our Internal Affairs

Chairperson Lao will be calling on people in the order they signed up.

SAL Lao According to our rules, you have to sign up to testify. The list is outside. If you didn't get

a chance to sign up, you may do so now. You have 3 minutes to speak. Our constituents get to go first, meaning full-time undergraduate students. First person is Chris Beymer. Also, I'd like to mention that if you submitted written testimony, we do have copies of

your written testimony if you've submitted them up until today. Unfortunately, due to technical difficulties, we only have one hard copy packet. The senate is looking through

them now.

Chris Beymer My name is Chris Beymer. I am an undergraduate Senior at the University of Hawai'i at

Mānoa. I am in strong support of SR02-18, which is in opposition to the change in Sinclair's hours. Sinclair is the one place on campus I know that will be open whenever I need it during the week. Sometimes I'll have to pull an all-nighter and I'll know Sinclair has my back in those early hours in the morning, when I need it the most. I know those hours between 11pm and 7 am are not used nearly as much as the other hours in the day, but they are used during those hours because students really need those hours. So, please

do not change Sinclair's hours; it is a vital asset to the student body. Thank you.

SAL Lao Moving down to Aaron Nee. Did you submit written testimony?

Aaron Nee No. I am Aaron Nee. I am an undergraduate senior majoring in Math. I am in favor of SR

02-18. It feels like the time to do this is a little bit unfortunate. I don't understand why they didn't mention anything before this semester started or when last semester ended. It's a little bit of an awkward timing because students are using the library. It is an illfully timed notice. Personally, I typically stay there very late at night, since I have access to computers whenever I need it and I can find a place to study and sit. It'll be overnight, and I can find a place to sit. I don't think there's some sort of way we can justify

changing the hours.

SAL Lao Now, moving down to Jonathan Rosen. Did you submit a written testimony?

Jonathan Rosen Not to ASUH, just to the librarians.

SAL Lao You may begin.

Jonathan Rosen Hello, my name is Jonathan Rosen and I am a Biology Senior at UH. First of all, I want

to start by saying that the reason why they're saying the library is closing is a very nondescript line saying staffing and low usage issues. Being a student, I'm there almost every night, until at least 12:00 am, and I'd like to say from first-hand experience that low usage is not an issue. Those pods on the first floor are at least half full, the computer labs are at least half full. I see at least 10 people on every section of the first floor, however I don't know about upstairs. If staffing is an issue, maybe you don't need both floor open, but at least have one floor open. Second of all, this is a state university; this is a college, and how can you say that you're not going to make this a safe place to study and learn past 10:00? On top of that, some people have class here until 8:30 pm. When you get off at 5:00, you want to take a nap, have some food, and you're expected to get

all of your stuff done by 10:00 at a university, and what other options will be open if they do close the only library open past 10:00? If they close the last library open, then the students may have to fit in those study pods at the dorms, and there's no way that can accommodate everybody. On top of that, most people who go to Sinclair in the first place during that time are people who don't have anywhere else to go. They need the wi-fi, they need the resources and computers, they need the secure ID checks so they don't have to stay in random, dark places since the campus is not a well-lit place at night. Not a lot of places are well-lit except for Sinclair. We need a place that is both secure and has adequate lighting, and is safe and quiet until at least 12:00 or 2:00. Granted, I understand that money is an issue and that everything does run on limited budgets, and limited staff and limited funding and limited time, but if that's really an issue, the second floor is not really that big and I'm sure that past 10:00, the people from the second floor can fit on the first floor. At least close the second floor, but you still want to keep the first floor and computers open at least for a reasonable time, like 12:00. A lot of you guys are students and I'm sure a lot of you study past 10:00. We want a safe place to study to work on our degrees and work on our goals at this University.

SAL Lao Jason Len Thank you, Jonathan. Moving down to Jason Len.

I've already submitted an emailed testimony, but I'll just summarize it. The usage that they looked through - I'd actually like to see a little more detail of what the people are using and what they are doing, because from what I can recall from being there overnight, most of it could be solved from a large open area and computer lab. It doesn't need to be the entire library open because the circulation desk closes anyway. The other ones that I'd like to see looked into is maybe staggering some of the other library hours to account for Sinclair being open later. For example, the medical library is open until 1:00 every night, and I find it strange that the library that is very exclusive is going to be open longer than the library that is open to everyone. In addition, I believe that it opens at 6:00 in the morning. The other options for staggering libraries are maybe we could have Hamilton open earlier and have Sinclair open later, and have the same amount of total hours, just shifted so that there is not as much overlap so people have someplace to study. In addition to that, keeping the library open until at least midnight because the way the school is set up through Laulima, we have a lot of assignments that are due at midnight, and with that cutoff, it is nice to have an 11:30 cutoff at the library so people can submit when things are due. I close with a question of are we an institution of learning or are we an institution of the gym? Why does the gym have longer hours than the library will? Thank you, Jason. Moving down to Lamarcos Rayford.

SAL Lao Lamarcos Rayford

Hello, my name is Lamarcos. I'm an undergraduate Senior in KRS. I want to open up by saying that I use the library a lot. I probably stay at Sinclair library longer than I stay at my own house. I feel that for them to close at 10:00 is unfair to all of the people who use the library during that time. I also want to look at security. There are a lot of students going through the library, so if you stop the security checks at 9:00 pm; that could cause a lot of issues if non-UH personnel come in. I'm not saying that it is exclusive to the non-students, but I think that's an issue. Sinclair is the only place where we can eat; it has comfortable couches - you can actually relax and feel at home and feel like you're getting an education and a place to study. I was kind of confused with why there's a problem with the budgeting. I'm from the KRS department and I'm into athletics, but if students aren't getting a safe place for their education, maybe the football team can have some of their budget cut and reallocated to the other libraries.

Siera Yu-Nique Price

Hi guys, I'm a senior in business, so I do use Sinclair quite frequently. As a business student, we do work in a lot of group work, have a lot of study sessions, have a lot of group work that we all need to complete. We all have different schedules, so Sinclair is reliable. What makes Sinclair unique is the hours, and you can rely on them to go and meet up with other study groups. As a student who pays for their own tuition, I feel that it is a robbery that they are blaming this on a lack of funding, when we pay a lot of money for these resources. For them to just cut it is kind of a smack to the face. I just wanted to say that and put in my input to make this happen.

SAL Lao Saul Bernal Thank you, Siera. Moving down to Saul Bernal.

Hello guys, I'm Saul Bernal. I'm a senior studying Molecular Bioscience and Biotechnology. First of all, I think it is a shame for this university to not have a library that is open 24 hours. That is one of the benefits of a university. The other is that they are using the argument that they do not have enough money to overnight security and they need that money to fund for 100 classes. The 300 and 400 level classes are the one that people study for, so if you add easier classes, they won't attend the library. There are solutions. We could have a trusted system, where after 11:00, only people who have signed up can go to the library. Nowadays, there are many technological solutions that can be applied to the problem. For all that we pay we deserve a library where we can go

to at any time.

SAL Lao Aovai Cole Thank you. Next up is Aovai Cole.

Hi everyone, my name is Aovai Cole. I'm here to represent the Tinumasalasala Samoan Organization, which is an RIO on campus. I'm the president of the club, and I just have to say that a majority of our members are students who come to Hawai'i from the islands, so when they come to the state, they are living with family or they are living in tiny studio apartments, and a lot of them can't afford internet, probably for the first four months they are here on island. That was the case for me - I could not afford internet when I first came to Hawai'i, so I really relied on Sinclair Library to do all of my work. Another issue is that, like I said, most of our students live with family - they live in homes that have their siblings, their cousins, their aunties, their uncles. There's not enough space or privacy for them to do some quality studying. We all know that if we are not in the right state of mind, we cannot study or take anything in. Some of our members also work odd hours. They are escorts, they are security guards, and those students finish shifts at 1 in the morning, or midnight, and if Sinclair is not open, where are they supposed to go? We also use Sinclair for our study groups. We have study groups with all of our club members, and since everyone has odd schedules, if we schedule a study group at 10:00, and the library closes at 10, we can't have it. Also, just as an individual, I'm a biology senior. I'm a full time student taking many courses that require me to stay until probably 2 at night. This is the one resource I ask for on campus. I don't use the gym, I don't go to the movie nights, I don't do anything else but study and try to earn my degree. Thank you very much.

Hi. I'm an ICS major. I was going back and forth about saving something here today because speaking in front of a large crowd gives me anxiety, but I figured since I study at Sinclair library past 10pm every week, maybe I should say something if there's a chance it'll help Sinclair library keep its existing hours. I noticed something earlier when I saw that Sinclair library will now be open from 8am -10pm Monday-Thursday. I noticed that the Warrior Rec Center is open from 5:30am - 10:30 pm Monday-Friday, and as much as I like the option of a late workout as the next guy, but I would give that up for a 24 hour library. UH has a lot of cool recreational activities and services for a lot of us to support our studies, but personal, I would trade any one of them to have access to Sinclair and Hamilton Library for 24 hours. My reason is because that is the only thing I can think of outside of our classes and our professors that is going to have a significant impact on my

grades and my educational career at UH. Thank you.

Thank you, Clint. Moving down to Jihyeon Shim. Did you get a chance to write a written SAL Lao

testimony?

Hello, I'm an international student here, so I need more time to study due to the language Jihyeon Shim

barrier. In Hawai'i, there's not a lot of cafe to go to and study. Kissaten usually closes at 1 am. I don't want to have to pay \$6 for coffee that I don't want to drink. If the library closes at 10 pm, I finish class at 4 pm, I have dinner, I work-out until 7 pm, so technically I just have 2 to 3 hours to study. On Saturdays, the library close at 6 pm, so there's no

time for me to study.

SAL Lao Okay, thank you. Next up is Rika Shinsato. Did you get a chance to submit written

testimony?

Rika Shinsato No.

SAL Lao Okay, you have 3 minutes to speak starting now.

Rika Shinsato Hello, I'm Rika and I'm an undergraduate student. Generally, i regard what UH does

with apathy, but this time I really have to speak up because this is the resource that I actually use. Last year, I had a part time job. My laptop was broken, so I needed a computer to do my work, so the only place I had at that time to go to was Sinclair. It is where I go to study with other people for group projects and stuff like that. I think it is pretty unfortunate and unacceptable that UH decides to cut its hours without contacting pretty much anybody and pretty much springing this on us all of a sudden. I feel that this is what UH does a lot. It uses its funds for whatever they want without really contacting us or letting us have any input at all. I just want to say that Sinclair is really important to me and other students too. This is a school, should be a school first and foremost, so I

feel that a 24 hour library is a necessity for all of us as students. Thank you.

Thank you. Moving down to Quinn Patrick Quinn Patrick O'Malley. Did you get a

chance to submit a written testimony.

I've only been in the UH system since the beginning of this semester. Being able to stay Quinn Patrick O'Malley

in that library until after 10 has helped me immensely with getting homework done on time and studying. I was there on Sunday, Monday and Tuesday until at least 1 in the morning studying for a math exam I had today that I'm pretty confident I got an A on. If that library had been closed at 10, then I wouldn't have had the chance to go in and use the computers and use wifi access since I don't own a computer simply because I can't afford one. There's no internet access in my apartment. So if that library had closed, my grade on that exam I took today would have been very different. Seeing that it is going to close at 10 starting on October 1st has me nervous about my future exams and keeping

my GPA high enough to hopefully get accepted into graduate school and then PhD program. I can understand not being open 24 hours, but closing at 10:00 is really too early. There are plenty of people there at midnight. I've noticed that it starts emptying out from 1 or so, so maybe instead of closing at 10, you could close it at 2 am or 3 am, or something like that. Closing at 10:00 is going to be detrimentally to not just myself, but plenty of other students as well and future students who are still in high school and junior high who haven't entered college yet. So, I feel that closing it at 10 is not looking out for the best regards of students and their grades and them succeeding in college. That's about

SAL Lao Asami Kobayashi Thank you. Next up is Asami.

Hello members of ASUH. My name is Asami Kobayashi. I am a biology major in the College of Arts and Sciences. Today I am here in support of the resolution because I cannot stress how important it is that we keep the hours of Sinclair Library. As a Biol major, we have had classes where it is highly suggested that we form study groups for classes such as biochemistry, organic chemistry, calculus, etc., and when we have study sessions, it almost always goes past 10:00, sometimes until 3:00 in the morning. And so it is critical that we have a space where students can study as a group where there's whiteboards, where there's round tables, where there's computers provided late at night. And so for me, it is pretty much essential that we have it open until. Also, another point is that we cannot keep allowing the university to cheat us! They have been incrementally raising our tuition, the administration gave themselves a million dollar pay raise not too long ago, and they're considering funneling even more of our tuition money into Ka Leo instead of figuring out a way to make it more cost efficient! Now they are shorting us of the library hours, and as a student who pays good money for quality education, this is a disgrace! ASUH, please continue to fight for the students' best interest.

I feel that the library is that place to make people better students and achieve what their goals are and give them the opportunity to be the best they can be. So, that's it. The pursuit of academic excellence.

SAL Lao Nelson Masang Jr. Okay, thank you. Next up is Nelson. Did you get a chance to submit written testimony? I did.

Most of us pay our way through college, and a lot of us take up work as mentioned earlier. Some of us work really odd hours at night, and the only time for us available would be far beyond 10pm to come here and study and get our assignments

done. So, I'm just here to support and give my testimony, and I hope that we can save the hours for Sinclair. Thank you.

When I got the email that the Sinclair Library hours are getting cut, I got really worried because I have nowhere else to study. Well, I do, but they're not comfortable places, like the lounge in the dorms or in my room, but I don't have a true space to focus if it's not the library. I feel that cutting the hours would really hurt my study process, because it takes me a long time and I can't focus in a small space, and I need the library to help me focus. I feel like cutting the hours to 10 is not really helpful because we already have Hamilton. If there was a better plan, it would have been better to cut Sinclair library hours during the day when Hamilton is open, and open up Sinclair after Hamilton is closed so it will save money and also give people the chance to be able to access the library so that people are not limited to hours. People like me who take a nap in the

afternoon, and wake up at 8 to study.

Travis Lovato Hi everybody, my name is Travis. I just want to say that it angers me that the school

wants to limit the hours. I'm a pre-medical student and I take my school work very seriously. I'm getting married soon in January and probably will have to work pretty soon. My schedule as a pre-medical student is not cut and dry, and a lot of students schedules aren't like that. I get emails for events that aren't even related to my major. I don't think a majority of students care about them. I thought about what would be the reason for them to do this, and it's probably financial. I don't understand because they keep the lights in the gym on 24/7, and they probably keep the lights on in the library 24/7 whether there are people in there or not. The only staff I see in there is 2 security guards, so it just really confuses me why they can let this happen. I don't think it's reasonable. I just wanted to say that. Thank you, guys.

Grad students

SAL Lao Thank you. Moving down to graduate students. First up is Kalawai'a Goo. Did you

submit a written testimony?

Kalawai'a Goo No, I did not.

SAL Lao Okay, you have 3 minutes to speak, starting now.

I support all of the previous testimony in not modifying the existing hours. If it's about Kalawai'a Goo access, I think it should be open longer. I support everyone from the previous testimony, but I'd also like to offer a thing called emotional contagion, which is something that we do when we go to a place and pick up on its energy. This was kind of touched upon earlier. So this is the idea that I can study at this place, I can sit on the couch when I go home. This is a very conducive place for studying. For them to take this access away, there's a lot of barriers to get an education, the cost of tuition, which are very stressful.

So, I'm here to help move this forward.

Okay, thank you. Next is Diliaur Tellei. Did you get to submit a written testimony? Diliaur Tellei

SAL Lao That is fine. You have 3 minutes starting now.

I'm Diliaur and I am a graduate student in the Computer Science Department. I am here in support of SR 02-18. I am also the advisor of the Micronesian Connections Club. Personally, I disagree with the sudden nature of the announcement and the utter lack of transparency and their reasoning. Among my colleagues, it was brought up that a flagship campus without a 24 hour library is, frankly, kind of embarrassing. Not only that, but I live on campus, and Sinclair is the most accessible, closest option with the best hours, and also, it's free. I don't have to go to Starbucks or Kissaten, and pay for drinks for wifi. Echoing what Nelson said, our Micronesian club members frequently use Sinclair to

study and meet. Our members need flexible hours due to their working schedules and living arrangements. Ultimately, we do understand budget constraints, but the way in which it was done and the way that administration has spent money in a questionable manner, and the fact that the hours would be so limited, is unacceptable to me. At least there should be a compromise that takes students' lived experiences into account.

undergraduate study here. I have an office now, so I study there, but I'm here to show up for my undergraduate friends and students that I teach General Chemistry Labs to. I want to echo some of the other testimonies that I heard. To be a public research institution without a 24 hour library is like, "What are you guys doing?" Also, to say that, The way that this was handled sends the wrong message to our students. I tell my students that even though you are not interested in chemistry, there is still something that you can take away from the class, such as learning how to use their higher intuition to solve complex problems. For the university to say that this is a hard problem is not in the spirit of investigation and innovation that this university should be instilling in our students. Thank you. SAL Lao Thank you. That is it for the testimonies on the list. Does anyone else wish to testify?

Cathy Ferreira My name is Cathy Ferreira. I transferred to here from Kapiolani Community College. I

would like to speak on behalf of my two friends who are KCC students. I myself came here the last two years to come to Sinclair library just because it was open after our library was closed. This was really important to me, and the students here are still doing that as well. They are not a part of the UHM system, but they are a part of the UH System in general. I felt that I need to take ASUH, the Senators, and the advisor for allowing us this opportunity to speak up and say that the library should be open until at least 12:00 if

not 24 hours.

President Dela Cruz To wrap up this portion of the meeting, I'd like to say thank you for coming to this

meeting and submitting testimony, whether it was in person, verbal, or through email. This shows how much support you have for this issue. That's why we are all here and convened a Special General Senate Meeting to address this issue. We have a resolution that you are all aware of that we will be introducing. Your voice's that you have shared

with us today show your support and help us create this stance.

SAL Lao

I have a question about the purpose. Reading through it the first time doesn't make it clear whether this is going to be an event or not. The line items under appropriations make it seem like an event, but the title makes it sounds like supplies for an awareness

campaign as opposed to some sort of event.

SAL Chen

Per Advisor Manini's discussion with us, we didn't want to put a specific date out, yet. We have something planned out, but nothing has been set in stone. In terms of reserving

the venue, we wanted to be vague.

SAL Leval

To clarify, the reason why the purpose statement is vague and doesn't include date and time is the Ad-Hoc committee, under the advice of Advisor Manini, has decided to keep the strategy details undisclosed so the strategy is not compromised by people who might

not support this initiative.

Advisor Manini

I would just say under the purpose, "To appropriate funding for a "Save Sinclair" Campaign." and strike everything else in the purpose, since you don't have to say anything else. The Ad-Hoc committee is going to decide what to do. I remember you guys talking about purchasing poster, paper, refreshments. It seems that there will be students sitting in the sun and out late at night, so people will need bottled water to stay hydrated and small snacks for sustenance. This is why the numbers wouldn't be as high. I'd like to also answer that question as the lead for the Ad-Hoc committee. The title

encompasses all advocacy efforts regarding the library hour change issue, so campaign encompasses any efforts, including tangible goods needs to support these efforts.

Senator Finau

I am in support of what this bill is, but I would like to entertain a motion to table this under further planning has been conducted to understand the actual amounts. I feel like just guessing the amounts isn't the smartest thing. I feel that there wasn't enough planning to come up with a bill right now. I also don't believe that an event will be happening between now and next general.

President Dela Cruz

Because of the processes that ASUH goes through in terms of funding, it would take at least 2 weeks because we have to approve of the minutes. We wouldn't be able to buy anything until the next general senate meeting, which is limiting because we need to start buying things for advocacy efforts dependent on what the Ad-Hoc committee decides to

Senator Finau

I'd like to retract my motion. I would just recommend that further information is provided because there is very little. I presented it because I understand the planning process in planning events, and I do not think that it is wise to estimate the budget especially through a bill. I'd like to recommend to the committee to do more research. . I echo Senator Finau's concerns. For me, it is hard to appropriate \$1,300 that are student monies towards something that has so little details and purpose. However, I understand

SAL Lao

that if we don't pass this tonight, we wouldn't be able to purchase anything for another three weeks. With that being said, I am in support of this with reservations.

VP Urasaki

I understand the concerns of Senator Finau and SAL Lao. At first glance, the bill seems vague, and it was done so with a purpose. I believe that you two are now on the Ad-Hoc committee. When we meet as ad-hoc committee what we have planned, I can assure that the details will be less vague. We can always allocate less or more money by recalling the bill. You are now on the committee, and we are looking for your input. We have stuff planned that was purposely not put on the bill.

SAL Chen

We have specific things we want to buy as supplies, but we wanted to leave it as just supplies instead of listing everything we intend to purchase. In our conversation in the Ad-Hoc committee, we talked about supplies such as signs, paint. We wanted to leave this as general line items so we can have alternative price checks. We did price checks for the items we intend to purchase.

Advisor Manini

Your purpose is advocacy, so investing in purchasing blow-horns for this initiative can be kept for future use for advocacy. With this particular event, regardless of how much experience you have with planning events, this is a very time sensitive event, so everything has to be accelerated, because we don't have time, which is why we are special ordering things. October 1st is going to be right around the corner. This is not going to be the same as other events that we have done. We will probably be doing things overnight that would normally take 3 or 4 days or a week to do. The timing for this initiative has to move fast.

SAL Honda Is this an awareness campaign or is this a protest? I'm not sure how you guys see it, but I

see them as two different things. Also, how much funding is Sinclair Library down by to extend their library hours? I feel like we should be putting our money towards an actual

solution to the problem.

President Dela Cruz To answer your question, it is not to raise awareness of the issue, as it has already been

brought up by the administration, but it is to raise awareness to the public as well as to

our UH administration. That's what the purpose of this campaign is for.

SAL Lao I'm looking at the University of Hawai'i's budget appropriated to the library. If you want

to look at it, it is available online. This is for July 2016.

SAL Honda I just want to say that we should actually put our money towards something that can solve

he issue

SAL Leval When we say Save Sinclair campaign, it encompasses everything under such campaign,

whether it'd be awareness issues, advocacy efforts such as protest, anything having to do

with raising awareness about student concerns regarding the new changes.

President Dela Cruz There are other solutions in terms of how we want to approach this. The Save Sinclair

Ad-Hoc committee is working on a strategy and approaching this issue, which includes writing a letter to the Interim Chancellor to possibly put a halt on this. If these do not fall through, then this is our strategy and so we would need the funding for these supplies.

Aaron Nee I would suggest writing a petition and having students sign a petition agreeing to keep the

library hours as they were before.

President Dela Cruz Thank you. That is an idea the ad-hoc committee has talked about.

Senator Utashiro I would recommend to increase the amount for supplies and refreshments. Seeing how

much supplies and refreshments could cost, it might be a good idea.

Senator Finau I am in support of that, but is there a fee for the new permits to distribute food?

Advisor Manin Closed package and pre-packaged items do not require a permit or handwashing station.

If the items are pre-packaged such as bottled water and pre-packaged snacks, we do not

need to go through the permitting process.

SAL Chen What should it be increased to?

Senator Utashiro I think increasing supplies to \$2000 and refreshments to \$1000, just in case. We can

always readjust it after the event.

Senator Finau I'd like to recommend decreasing the line item for supplies to \$1000 or \$1200. I think

\$2,000 is a little too much.

SAL Chen I think that is still a bit too much. Maybe \$800. If anything, we could recall it.

Senator Utashiro I understand that you can recall it, but in the interest of time, if you realize that you need

more, then this would act as a safety net instead of having to recall it.

Senator Finau I agree, I think having a safety net is important. If we have to recall the bill, then we

would have the same time issue that we would have if this bill was tabled. So, I think it is

better to overestimate.

SAL Leval Move to increase supplies to \$1000, Refreshments to \$800, and have the totals reflect the

changes.

your resolution to pass at our neighborhood board meeting? I'd like your guys'

permission first.

President Dela Cruz Yes, you could say you support the ASUH resolution or take ideas from it.

Student Being a student from KCC, I was wondering if other campuses have been notified of
