a. Counseling and Student Development Center (CSDC) presentation by Allyson Tanouye, Richard Mizusawa, & Joel Gaffney

Richard Mizusawa Good evening, my name is Richard Mizusawa. I am with the Counseling and Student

Development Center as a Coordinator for Communications, Programs and Development. I'd also like to introduce you to my supervisor Dr. Allyson Tanouye and Joel Gaffney. I would like to be very brief with this. We wanted to reach out to ASUH to inform them of

the services that we do offer. We hope to give a brief presentation on this.

Begins presentation

Richard Mizusawa This is an overview of what we do want to go over. This is not just for your knowledge

but also for you to pass down to your constituencies that each of you represent. Our mission is to provide high quality mental health services. Our service are geared towards the individual needs of the student. We are a very unique community and are responsive

to the unique diversity we have.

Joel Gaffney As Richard was saying, we are a group of professionals who are here to provide services

that you pay for through your student health fee, to provide support for the students, and we are here for the diverse array of mental health needs. We are open to everyone.

Richard Mizusawa Within our center, we have 4 psychologists, 2 psychiatrists, 7 staff therapists, 3 student

interns, 1 practicum student, and 2 office staff, in addition to student assistance. We also have a testing office, where many of you may take your GRE and MCAT. We do serve to mental health and counseling needs of the students. These are the various programs the CSDC oversees. We do personal counseling, couples counseling, group counseling, peer

mentor services, and emergency and crisis counseling.

Joel Gaffney Everything except for psychiatric services is paid for by student fees. From 8:30 am to

4:30 am we accept walk-in appointments for emergency crisis services. We would like to speak a little bit more about group therapy. It is essentially the same thing as individual counseling, but with a group of people. It can be cool and powerful for people to connect with a group of people and providing feedback. These groups run through the current semester. We want people to be aware of these groups. We are also starting to offer a few walk-in workshops. These are things that students can sign up for. There are

workshops such as mindful meditation and managing stress.

Richard Mizusawa We have a healthy relationships event coming up at Campus Center on February 14 from

10:30 - 2:30 pm. We will be doing a lot of educational activities. We have a big social media campaign with big prizes. We also want to offer this presentation to other student groups. If you know of any other student groups who may find this information useful, please do let us know. We wanted to emphasize one involvement opportunity for students. We have our peer fellowship program. We have 5 positions for the 2017-2018 academic year. A peer fellow is a student who provides psychoeducational programming

and peer support. There is a stipend for it. Please tell your friends who may be

interested.

Joel Gaffney This is a great opportunity for people interested in going in the helping field. To make an

appointment, you can call center to say you're interested in scheduling an appointment.

Right now, the wait is about a week for intake appointment.

Richard Mizusawa Before we conclude our presentation, we want to thank you. I've been in touch with

President Kamoshida and know you guys have a priority for two of the bills to fund

additional psychologists. Thank you for your support.

Senator Arenivas Have you had any outreach with the Office of Veteran Student Services

Allyson Tanouye Yes, their office is nearby us.

b. Hawai'i State Senator Stanley Chang

Stanley Chang Good evening everyone, my name is Stanley Change from the Hawai'i State Senate. I'm

here to speak on Senate Bill 23-17, to appropriate funding for a College Student Mental Health Luncheon. I think mental health is one of those issues that is really important but doesn't get the attention it should get. I think this is a good idea for three reasons. First of all,I think we are all a little bit crazy and have something. I'm sure we all know people who are affected by things such as ALS, breast cancer, but everyone I know has

some sort of issue, whether it is an eating disorder, sleeping issue, anxiety, OCD, depression, and I think this is very common among the high-achieving people, ambitious college student types. The second reason is this is a big society issue, and I think mental health issues are incredibly stigmatized. I have a friend who would rather admit, and he does publicly admit, that he has erectile disfunction, but he will not admit he has anxiety. That, to me, is insane, to be less embarrassed by something like that versus a mental health issue. I think this is a huge problem in society as a whole. This is why I want more dialogue and discussion on mental health issues. This is why I tell people that in high school I had a mild eating disorder. I sort of know what it is like, I did not go through horrible health symptoms, but I remember feeling that my world was spinning out of control, but the one thing I could control was how much I ate. It was not about losing weight, but about the feeling that that was something I could control. I can sort of understand how people are thinking when they go through eating disorders. I think we should try to help to remove that stigma. Thirdly, I think that because of this stigma, mental health is viewed in a fundamentally different way from physical health. The standard for getting treatment for mental health is if it affects your daily life. Affecting your daily life is essentially a euphemism for ruining your daily life because you're missing work, you're missing class, you're missing exams, you're isolating yourself from social relationships, and that is a really horrible standard. We should all be treating mental health the same way we treat physical health. I think it is important to have a luncheon, where we can have people talk openly about their issues to show people that there is nothing to be afraid of and nothing to be ashamed of. Also, I think this luncheon is important to introduce people to the resources that Alice and Richard are about to introduce to you and also to give people tips on how to do better in mental health, whether it's sleep, hygiene, keeping time for your relationships. I hope I had this in college, which is why I'm passionate about it, and I hope this measure will be taken into consideration.

Begin Testimonies

Sean Mitsui

Good evening members of the ASUH 104th Senate. Thank you for your time and consideration for this resolution in front of you. I am particularly talking about SR 10-17 in support of disbanding the Student Athletic Fee Committee and establishing a two-year moratorium. My name is Sean Mitsui. I am a former Senator of the College of Arts and Sciences of the 100-102nd Senate and Senator-at-Large of the 103rd Senate and I served as chairperson of the Student Affairs Committee Investments and Long Range Planning Committee. You may be asking why someone who has graduated is here today. I'm just here to provide a broader context of this resolution and talk about it through a point of view as a historical witness of SAFC as an organization by providing my own anecdotal accounts. SAFC was an organization that started with great intentions and it was a compromise in exchange of the newly implemented athletic fee, at the time \$50. Comprised by the leadership of the CSO's, the organization was structured, but proved to be a big flaw because SAFC recruited people who were already actively involved in their organizations. If you look at SAFC's website, you can see that there are many problems with the directions and objectives that they have as organization and how it allocates their resources. To give you an example, when I was a student here, there were times when SAFC would fund certain events, but the next semester they wouldn't. I think I remember one semester they had RIO funding, which ASUH and SAPFB do as well, but they suddenly stopped doing that because there was a conflict with the leadership styles that organization was composed of. This lack of consistency and transparency is a reason why people might know about the various CSOs but might not have heard about the SAFC. I would be confident that most of you have not heard about the SAFC until tonight. There have been talks about Athletics increasing the fee, and supporting this resolution would indicate that you are opposed to further burdening the students by

giving back this 8% of the fee back to Athletics for moratorium. ASUH has been critical of any fee increases and organizational bodies such as SAFC. For this reason, I humbly ask for your support for this resolution. Thank you very much.

Brendan Burk

Hi, my name is Brendan Burk. I am the current SAPFB Chair and currently a member of SAFC. I, like Sean, was a former member of ASUH. I used to chair the Finance Committee. I submitted written testimony that details some of the arguments why I support this resolution. Without repeating all of that to all of you, my perspective comes from somebody who was around UH during the time the athletic fee was implemented, as somebody who was a part of the SAFC previously, and someone who is a part of it again now. As Sean has mentioned, one of the challenges I see is that as more time passes since the SAFC was formed, there's this lack of historical knowledge, so nobody really knows what SAFC intended to do or what they are doing, so you have new leadership who have good intentions to restructure it. Having been here in 2010 and now in 2017, the problems have not really resolved themselves. There's a lot of internal consistencies in the way the committee is run. SAFC generates about \$144,000 in fee revenue off of its 8%, and they get to keep \$70,000 of that, with another \$70,000 going towards Mānoa Maniacs. My biggest argument is the purpose of SAFC was to provide student input of how this Athletics Fee gets utilized on campus and to serve as this oversight body to make sure that Athletics doesn't take its own direction. SAFC is just replicating services that all of the CSOs that exist currently provide. It is your duty as the undergraduate student government to lobby and advocate in the interest of the undergraduates. It is the GSO's responsibility to advocate for the interests of their constituency. SAPFB is one of the main providers of RIO funding support. There is not a special need that SAFC established as to why they should exist and what they actually serve that none of the other CSOs can implement. I will stick around for questions during the arguing of the resolution. Thank you for hearing me out. .

I've been keeping in contact with Representatives Ichiyama and Choi regarding the bills that ASUH is pushing for in this legislative session. The first bills are HM 967 and SB 1164. SAL Urasaki Besides what Senator Chang already mentioned, we want to give students the opportunity

to informally talk about mental health and wellness. It is something that people don't really want to talk about, which is something that should change because it is important. ASUH would collaborate with Senator Chang and the CSDC. Senator Chang said he was willing to facilitate the discussion and CSDC said that they will also provide counselors to facilitate. Our whole goal is to not only bring awareness of mental health and wellness, but also to encourage them to submit testimonies for what we are trying to do at the

capital as well.

SAL Enriquez I'd like to express my main concern in regards to this bill. I would not like to assassinate

the purpose - I do believe that mental health is an issue we should be tackling here - however, the processes in order to special order this bill is unprecedented as it ultimately usurps and disregards the institution we have here in place within ASUH. The discussion we are having at this point in time should have been reserved for the Finance Committee, as that is there power and place upon which to regulate and to make sure the funding that we are appropriating is within our means to do so. I do believe that by doing this we are sort of handing out a blank check. We do not really have any hard, specific details in regards to the time, place, and date for such an event. I do realize that there has been a precedence set with past bills, however, we have a carefully crafted institution and I find it disrespectful to the process that we have to special order this when we have no pulse

nor indicator on what we can or can't afford.

Treasurer Hinshaw You put two different accounts. In Section II you put Senate Account 3325232 and in

Section IV you put Senate Account 3325222. To clarify, I believe you meant to put it under 3325232. Move to change Senate Account 3325222 to Senate Account 3325232

Treasurer Hinshaw Before we begin, I would like to point out that the underlined portions were added.

Anything that is underlined is a part of the resolution. This bill addresses a few things. Firstly, rather than having an Athletic Fee Increase, we can give the 8% back to the Athletics department. ASUH has expressed opposition to an athletic fee by introducing

SR 03-09, 10-09, and 02-13, as well as opposition to the Athletic Fee increase by

introducing SR 11-16 last year. SAFC was created in position of monitoring the Athletic fee. However, this puts an additional responsibility to each of the CSOs, which could be splitting us up because the representatives of the SAFC are representatives of other CSOs and they are usually more involved. Initially SAFC does not provide any unique services, as one of the testifiers mentioned. SAFC does not track if student engagement has increased at athletic events. Hopefully, if the Athletic department does agree to take the 8%, they will report to elected student government organizations, such as ASUH and GSO, and report how the fee is implemented and if it is increasing student engagement.

For those of you who do not know, I am the Vice Chair of SAFC and we had a meeting today discussing rearranging the SAFC. Basically, what we came up with is we would have a membership structure. We would take the CSOs out of it, and open it up to 5 undergraduate students and 2 graduate students. We would send out applications, and basically that is what SAFC would be at that point. Campus Center Board is voting on Monday to not be a part of SAFC, regardless of disbandment or anything else. We have that on the floor today and we are supposed to come back as soon as possible with what our CSOs think about this proposal. With that said, I would prefer that this be tabled so we can go through this a little bit more. We should go through this proposal before we speak on this through a resolution. Move to table this resolution. Second.

Treasurer Hinshaw Treasurer Hinshaw

I would kindly ask that you'd not table this because I will be leaving on Sunday, and since I am the sole introducer, this would prevent us from going over this again. Since there are representatives of each CSO currently there, we didn't know that you were the SAFC Vice Chair. We didn't get any input or comments on how SAFC was functioning until today. How are we supposed to know how the SAFC is using the 8% if it's from students we don't know of. You're our representative and a part of ASUH, and in the SAFC Meeting Minutes from October 28th, the Chair asked if you could report back to your respective CSOs and ask them if they should disband, continue operations, or change the membership, but I don't think that we heard anything from you.

We did, because I reported back to President Kamoshida. The last conversation I had with her was for disbandment. This proposal was brought forward today, so this is something that wasn't on the table before. I am willing to work on a resolution something like this. I feel we need to weigh all of our options at this time before we take a course of action. I didn't even know the chair would say that because we are all a part of CSOs.

Advisor Manini

SAFC's advisor is a member of the SLD, and we have been weighing options for the past 3 or 4 years, and have gone nowhere. My concern is that if you give more time for continued discussion, it will continue to go nowhere. I am familiar with CCB because I work with them. They have already voted to disband, and in their executive committee they voted to withdraw themselves from this entity if it stays in in function. They've already passed to disband, and now they are passing to remove their CSO if the other CSOs decide not to disband. I would like to clarify what Daniel stated in his testimony. I am not sure if dragging this on will change anything. If ASUH takes a position, and the SAFC continues to work, and they figure out a plan, and you are a part of that, that can still continue on, it's just that ASUH would be expressing concerns about it. This doesn't mean ASUH will pull out of the committee. Lastly, just because you put 5 undergraduates and 2 graduates on SAFC does not change the CSO's responsibility for the organization. The CSOs will still be responsible for making sure that the SAFC delivers what its goal is, and the SAFC has not been able to do that all of these years. I do not think that the attendance has increased, even though this entity has been using this 8% of the fee. The bottom is that just because you appoint 7 other members who are not

sitting on CSOs does not mean you take away your responsibility of making sure that they do their job. You still will be responsible for monitoring them. Can you do that

when you've had oversight of Mānoa Maniacs and that hasn't happened?

SAL Willis I am not arguing in favor of the realignment. As my colleague mentioned later, no one is

aware of the historical context of SAFC. I just thought that it was something to consider.

Since this is just a resolution expressing opinion, I will support this.

SAL Enriquez I would like to express that by voting to not table this, we will be able to proactively and

actively start something with this, so I would highly argue that it would be in our best

interest as ASUH to not table this piece of legislation.

SAL Enriquez This resolution was written in support of GSO's efforts to call for the renaming of Dole

Street to Kapa'akea Street. I would like to highlight that there were concerns within my

committee and I would like to call upon them to voice those concerns.

Senator Finau I voted nay because I don't believe that this is something the student government should

be involved in. I believe that it should be brought forward to a higher group. I do not think that this is something we should be directly involved in. If the language was worded such that we expressed support towards the Mānoa Neighborhood Board's stance, I think that would be better. However, because of the grand nature of this, I don't

feel that this is within our jurisdiction.

Senator Leval I also voted nay on this resolution for similar reasons as Senator Finau just said. I also

wanted to point out that there were a lot of holes in the resolution that we found, one of them being that we need to double check whether or not Dole Street was named after Stanford B. Dole in particular, or the Dole family in general, because I know that is a discussion that came up. Another thing is that the committee did not get a chance to see the GSO's resolution on this matter, so we felt we could not vote in confidence on the resolution, especially since we did not get to see a document that resolution says we support. We also had some questions as to a Ka Leo article we looked at talking about neighborhood opinions about the renaming. We could not find any numbers as to whether the residents of the neighborhood were in support of such a naming. For these reasons, I

voted no.

Senator Finau In addition to what Senator Leval said, there were no statistics based on students with

Hawaiian ancestry and if this directly affects them, so I do not feel that this is accurate. I also feel like if you vote nay to this resolution, that does not necessarily mean you do not support the idea of renaming of this street, I just think this is not our decision to make.

Senator Honda I'm against renaming it, because I think when we look at a situation like this, is renaming

the name going to solve the problem? Is renaming the street to Kapa'akea Street going to take back what happened with the Dole family? I don't think so. I think it is not healthy for us to just change something and pretend it's not there whenever we are offended by something. When I was on the Board of Education, something that was brought up was McKinley High School. It never went through because it wasn't going to change anything. It is similar to Dole Street. People have known it as Dole Street for a while,

and changing it would cause a lot of problems.

Senator Arenivas I voted nay for similar reasons as Senator Leval and Senator Finau have said.

Senator Barrow Who conducted the research the committee looked at?

Senator Leval We are not sure who conducted the research, so even more so, it threatens the ability of

any research done.

will be in Hamilton Library.

SAL Enriquez I would like to voice my strong support for this bill, as I find the historic preservation of

ASUH and their records is essential to our organization as we will have a database as reference to look towards for future programs that we may partake in as a student government. Also, having previous experience as an archivist, I do express that the cost for supplies is worth it, as having supplies such as acid-free folders ensures the secure

storing of such documents.

Senator Arenivas Since the supplies are expensive, how do we know that \$800.00 is enough?

VP Dela Cruz Healani probably got the quote from the archivist herself. Senator Barrow How did we arrive at \$6,200 for the Student Archivist?

VP Dela Cruz This is her "pay" for three years. After this, there would be no need to fund for another

student archivist.

SAL Chen The other half of the cost is coming out of the operations budget, which is meant to help

fund and operate the ASUH office.

Senator Klinestiver Have you gave them money before?

VP Dela Cruz Yes, we have. I would have to check the acts.

Advisor Manini I am concerned about the questions being framed. It is not about funding people outside

of ASUH, it's about funding your own operations. It is a matter of prioritizing your funds to take care of your own internal business, which is your records. This is for your

own operations.

VP Dela Cruz This is just for this year. There was an act that was approved last year. The 103rd Senate

approved \$500 for equipment, \$800 for supplies, and \$5,000 for the Student Archivist.

Senator Leval Can you explain why there was an increase for the Student Archivist?

VP Dela Cruz I'm sorry, I do not have that information.

Senator Klinestiver Move to change Student Archivist from \$6,200 to \$5,000.

Senator Barrow Second.

Senator Ishii I'd like to point out that for students paid through SECE, there are raises given to their

employees automatically, so taking this into consideration, there would be an increase

from last year's allocation.

SAL Enriquez I would advise against decreasing this line item.
