Advisor Manini

I have opted not to speak with the senate directly about this legislation. I am a faculty member, and I am tenured, and I am considered non instructional. At this point, I am not professionally impacted, but I know the profession will be impacted. I cannot in good faith support my current students because I feel like that is not appropriate. But since it was brought up in this meeting. I just want to say I have my personal testimony that I am submitting on my publicly available Facebook page, so if anyone is interested in reading my testimony regarding this piece of legislation, then please go ahead. I don't mention ASUH in general, but I do mention advising an organization like yours and a conversation I have had recently with one of the students in ASUH. It is really to exemplify the teaching that goes on even in an informal type of relationship like what we have that is not a class for credit. I'll just leave you to that. The senate, you guys, has to decide what it wants to do, and I am neutral in what you decide to do. I just thought I would share that since you are not faculty and may not understand the issue fully.
