TO APPROPRIATE FUNDING FOR THE SPRING 2025 REGISTERED INDEPENDENT ORGANIZATIONS (RIO) FUNDING CYCLE

BE IT ENACTED BY THE UNDERGRADUATE STUDENT SENATE:

SECTION I. PURPOSE

To appropriate funding for the Spring 2025 Registered Independent Organizations (RIO) Funding Cycle.

SECTION II. APPROPRIATION

A total of \$5,725.33 shall be appropriated from account #3325242.

SECTION IV. PROVISIONS

RIOs receiving funding must submit all paperwork for Spring 2025 events by Friday, May 13th, 2025. Failure to do so will result in the event not being funded and future funding being denied. Any unexpended or unencumbered balance of funds appropriated from this act as of the close of business on May 13th, 2025 shall lapse into the appropriate accounts. Any RIO is reminded that any such proselytizing of religious beliefs or cultural insensitivity shall result in the denial of funding and elimination of consideration for future funding by the ASUH. All RIOs are required to use their funding for the benefit of the undergraduates at the University of Hawai‘i at Mānoa. Any RIO awards related to lodging and transportation shall only be provided via reimbursement. Even if time permits, for direct payment, these items must be by reimbursement only due to liability. If the transportation allocation is for a bus or shuttle service and time permits, it is acceptable to do direct payment. Direct payment is if the office works on a purchase order for the items. All funding is pending approval of the ASUH budget by the OVPSS.

SECTION V.

The ASUH shall be recognized as partially funding this event on any materials or advertisements after passage of this bill. If the RIO does not recognize the ASUH as partially funding the event on any materials or advertisements after passage of this bill, it will result in the denial of funding and the possible elimination of consideration for future funding. Partial funding of said event shall not constitute co-sponsorship by the ASUH. All recipients of the ASUH funding shall file a post activity report within sixty (60) days after final payment has been made.
