a) COVID-19 Academic Policies

President Li I just wanted

I just wanted to give an update on the COVID-19 academic policy. As you guys saw, the email has gone out saying that the University of Hawaii system is now doing credit/no credit grading. it is going to operate in the way that we have supported, students will be able to view their grades before choosing a credit or no credit option. The email also

denotes that Credit/no credit will not affect GPA, and will also not hold back students from progressing into classes they need grade requirements for, to receive the grade of credit you must at least receive a C to qualify. The deadline to decide if you would like the credit/no credit option is May 22, just log into star to view your grades. Next to your grades there will be a drop-down menu with the option. I have brought up the confusion with certain departments to administration and they said at the end of the day, it is executive policy which will trump department decisions. The thing about this is if departments are going to fight this, I would hate to see students filing a grievance if they were denied acceptance into future classes opted into credit grades. Stress because this would create more unneeded stress and confusion. Stress because this would create more unneeded stress and confusion. I asked what the plan of enforcement is, and President Lassner said he will update me. I did see the travel industry management department email saying that their students should not take credit or no credit. But I am glad that it got squared away is key. Everyone should monitor any situations that come up like this so we can look into it.

Another item I wanted to talk about is the recent announcement from the state legislature regarding possible budget cuts. Employee wages across all state employees could be getting a 20% cut from their pay. This is substantial and will have a big impact on the livelihood of not only the faculty but students as well. I just wanted to bring up this discussion point to see what peoples thoughts were and what actions ASUH can take regarding this.

Just to be clear, information about the proposed 20% cut came from Governor Ige, Not from the state legislature.

My mom works as a government worker, so if this were to go through it would significantly impact her. I am just one student out of I don't know how many at UH whose parents do work for the government. If those parents do have their information reflected on FAFSA or any other educational thing that would help them pay for school, I think that will be a problem for students who would benefit from FAFSA or some students who depend on support from their parents will have to leave school. Also, I looked up the salary for the law school dean, and it says for the 2018 fiscal year that the Dean Soifer made \$416,000. So that is already a lot of money, but considering how the proposed salary will go up to \$430,000, I don't know if Soifer Will even be in that position or if it would be for the new dean that they are looking for. But that is still a \$14,000 increase, which is like 2/3 of the law school tuition for one year at the resident rate.

I am sharing a link that shares all the executive and managerial salaries in the UH system. So you can take a look at it. It isn't just the Law school dean, there are other people getting \$400-\$500,000.

In terms of the 35,000 a month salary, that is actually for the new hire. I think that I put a link on my Facebook page for the board of regents agenda that lists the person's name and their proposed salary. I think it is a consent agenda which means Bruno would have already gotten approval from Lassner potentially. I don't know how much that money actually helps the law school. At the end of the day it's the faculty and the students that makes the school great.

SAL Manabe Considering that a lot of the pick up of Richardson is already resident tuition, comparing

\$21,000 for the year for residents or \$44,000 for non-residents, the law school does not have a significant pool of money to pull from upper campus that has all of the graduate programs and undergraduate programs. If we take into account that the new dean gets a raise of approximately 2/3 of a resident tuition for the year, I don't really know what to think of that.
