Youth Research Survey: Legislative Civic Engagement of O‘ahu Young Adults and Teens (Presentation by Jannah Lyn Dela Cruz)

President Albano

I, as we've been talking in the past couple of weeks and I shared with you also on Monday. One of our ASUH reaches former senators and Presidents, Jannah Lyn Dela Cruz is working on a youth research survey, and we are very lucky that Jannah is willing to provide her time to share a little bit about the research survey that she's working on. And, you know, that we then find how we can help to support her and, yeah, just as we're you know even right now like navigating the legislative session so I believe that Jannah and the call I will go ahead and pass it over to her. Thank you so much Jannah for being with us this evening. And yeah, take it away.

Jannah Lyn Dela Cruz

Awesome, thank you so much for the opportunity

So again, My name is Jannah Dela Cruz and yes I was a former ASUH president amongst many other things I was in ASUH, a couple years ago. I'm really happy to be back here to share this project with you folks as I believe there's definitely a direct correlation between this research project that I'm working on and, like, it's within the realm of what you folks do as like student government leaders.

Just to kind of give you an overview of what I'm going to talk about. It's just for things so I just want to do a quick intro, talk about the project, it's timeline and involvement so like ways that you folks can become involved. Before diving into the project details, I just want to share that this is a UROP funded project. So, for those who don't know, UROP stands for undergraduate research opportunities program. It's pretty much a program that funds research projects and creative works for undergraduates at UH Mānoa. So currently I'm just taking one class. I'm a part time student studying architecture, and my faculty mentor actually is Bonnyjean Manini, your folks' advisor. The reason I had Bonny as my advisor is because she has his expertise, of course, working with student organizations, you know, Legislative Affairs especially like, you know, working with ASUH, as she is your folks' advisor. She understands like this, sort of like realm of things. Although I'm a student studying architecture, I'm conducting this project because I'm personally interested in doing more research relating to legislative civic engagement, particularly with, you know, our generation so millennials and you know Gen Z, adults and teenagers, pretty much. I'm not doing this for credit, and so pretty much this is like this independent, personal research project that I'm conducting this semester. So there's no ties with other faculty research, or my architecture program and whatnot, just to kind of give you guys a heads up on that.

The title of the project is legislative civic engagement of O‘ahu young adults and teens, this pretty much discovers but the scope of the project is pretty

straightforward. I don't know if you guys noticed but I believe like, this is an overall issue in itself. There's definitely like or with research backed, of course, there's definitely a lack of representation of folks around our age when it comes to Legislative Affairs and being engaged in civic engagement and whatnot.

Below here is just kind of like a quick fact sharing from the United Nations Office of the Secretary is envoy for youth, which pretty much states, or they have statistics that state that the age group of 18 to 25 year olds participate in like elections and whatnot, much significantly less than other groups, and they also have you know studies that pretty much confirm that majority of nations don't even consider consulting young people and national development. That can be seen within like the US and even locally here in Hawaii.

Just a little bit more background that kind of just set up the project. There is like some global and national research regarding youth civic engagement. And so here are just three points that I've kind of just took from doing a little bit of this research, pretty much confirming you know the lack of youth representation and civic engagement and government. There's research that, you know, supports the development and more research to be able to like support, educational means to improve use of engagement so creating more resources that help you know folks like us become more involved. There's research out there that also encourages the need to develop our established institutions that require like youth participation. So examples would be like youth councils, or youth commissions like creating these institutions that encourage people of our age to become more involved.

This is kind of just like a diagram showing how this project, that I kind of put together, fit into this overall issue regarding youth civic engagement. While providing more research like I kind of just mentioned, will help pretty much aid the improvement of civic engagement within adults and teens so this research can be used by these, youth and government, like institutions and establishments, educational institutions like colleges and high schools can also benefit from research relating to this overall, to support this effort to increase civic engagement. In particular this project is applied locally so it's focusing on the site of Oahu, and relating to the Hawai'i State Legislature in Honolulu City Council. This project aims to study those between ages 14 to 29 living on Oahu, whether you're a resident or you're just you know here for school or you're working here, and how engaged they are with our state ledge and the Honolulu City Council. The reason for this chosen site is that it houses a city council and the state legislature, so it's a pretty good start to contribute towards this type of research since currently, I wasn't able to find or access research about any youth civic engagement within Hawai'i. And so in the future you know after this project, others can look to this as an example, and possibly even apply this type of research to other islands or even, you know statewide as a whole.

This is just kind of like a brief statement of the purpose of the project to pretty much recognize what is the level of legislative civic engagement of the younger generation on O'ahu, and just overall provide more research that can inform our community, so that they can you know create more educational resources or develop different programs that would improve our legislators civic engagement. The goal of this project is to pretty much just gain this better understanding of our involvement and our knowledge with, you know, the local legislative process. You know in example the Hawai'i state legislature or the

Honolulu City Council, and at the end of the project hopefully we could identify solutions that can address any issues found in, in the research.

I'm not going to read all the questions because I want to take up too much of your time but you can briefly see it right here. These are four main research questions that the project aims to investigate, pretty much like does, you know, Oahu young adults and teens know about the Hawaii State ledge or the Honolulu city council, or how did they find out how did they know about this knowledge. Are they involved, you know, do they intern who they testify, things like that. What factors affect the level of knowledge, like do people have access to, you know, our government, and stuff like that. And then lastly, how can we become more knowledgeable or involved in these processes. So, in order to pretty much investigate these questions, my method or the method that I put into this project is to survey young adults and teens on Oahu via a Google form so the anonymous online survey for ages 18 to 29 only.

I've been making contacts with people I know in local schools and colleges such as you folks, to be able to help spread the word and test out the survey and see how it goes so that we can gain participation and find more research in this. At the end, I would analyze the survey data and present findings and solutions, regarding the data at the spring 2021 undergraduate showcase which is public. I think to everyone actually so you folks will be invited to it via like a mass email sent by UH and whatnot. I believe President Albano actually has sent you folks to survey. So I hope you guys you know take a second to look at it or if you haven't yet. But this is a brief table that shows the relationship between each question in the survey to the research questions, and the projects learning objectives, so it's a very detailed outline here, I don't expect you to read all this right now but I will definitely you know share this afterwards so that you guys can read it. Um, just to kind of show you that like this survey, definitely is trying to investigate the research questions, and it's not just some meaningless survey being sent out to waste people's time, like, this is meant to dive deeper into this whole subject.

Okay third part, the timeline. Pretty much, I've set up the groundwork for this project before the survey can run out. That took place in January and February. I've begun testing the survey with groups such as the student caucus, and then you folks are, you know, the next group that I'm looking for your support to help test the survey, and then regarding like teenager ages, I've reached out to the Hawaii State Student Council, and I'm in communication with them to test it. So, this month, and April is focusing on pretty much finalizing the testing improving the survey, and then publicly rolling it out so that we can get as much participation as possible to be part of this project. And then in April at the end on April 30 is the showcase and that's where I'll present the results of the data. The survey data and then like findings and some, some possible solutions.

So lastly, involvement. As I mentioned about testing, which you guys are familiar with. I'm hoping to gain some feedback from you folks, caucus, and the student council so we can figure out how to improve the survey so that there are better project results. And I'm also looking to your support to help spread the word of the survey as well, to encourage more people to participate and in case you're wondering, there is an overall benefit to the project overall which is pretty much being able to provide this research to support groups like ASUH or Hawaii State Student Council to improve engagement of, you know, your folks'

constituents when it comes to, you know, Legislative Affairs, and decision making matters, being held at the table for example. And then this is just a few of like, I guess my work cited or like bibliography. That's pretty much it. I just want to open up for any questions you folks have regarding the presentation or even like the survey, since ebooks already looked at it already.

President Albano

Awesome, thank you so much Jannah.

I just have a really quick question. So I know that you had, you know, I had already sent out the feedback form that you had made to folks to so that they can fill it out, but I was just wondering if there was any particular deadline that you'd like us to submit our feedback by if you have a certain timeline like next week Friday or whatever. If you have any right now.

It's kind of flexible so I will actually be testing the survey with high school students next week, Saturday. So, actually I'm hoping to gather as much feedback by that weekend, just so that you know we can roll out the survey as soon as possible. I understand that you folks have a lot of things on your plate with school, extracurriculars, so I can be as flexible as you folks need it, but I think ideally Friday next Friday or Saturday, would be a good deadline.

Yeah, thanks Jannah for sharing. I was wondering if you had a I guess like a graphic that you would want us to share on social media or something because that's something we could do to get the word out.

Yes, of course. So I do have a couple of social media ads that you folks could possibly use if you're interested in. I didn't include it in the presentation but I could send it over once I figure out if it's like okay cause I'm actually waiting for the institutional review or to make sure that, like it's good. So once I hear word on that, then I'll be more than happy to share it.

Are there any other questions? Okay, seeing none, I just want to say thank you very much Jannah for your time and for being able to present to us, we can definitely keep in touch.

I know we have our student caucus meeting next week as well and I know we'll probably talk about that then as well, but if there's anything you know I'll make sure to reach out to folks again just to remind them about the survey and provide any feedback. But yeah, we'll definitely keep in touch via email, and if there's anything else that we can do to support. Just let us know, but yeah, thank you so much for your time, we really appreciate it.

Senator Chua

I guess I'll start with something that Senator Keim was working on. Yeah, so she created a Google Sheet to track bills that will be shared with everyone on social media so if you find that you can use it. I'm thinking it might be on our shared drive as well. But if you want you can use it as a resource so feel free to do so.

And also we've been working on some bills like 727 that seeks to extend protections for survivors of sexual assault and violence on campus. Currently, because the date before the crossover in the Senate is really really near so we're just going to time crunch and we're hoping for it to be heard and at the Judiciary Committee at the end of the week. Even if that particular bill that we've been tracking is not heard of a deadline for all hearings, I think, in this case would be Friday so I believe today is actually the deadline that they would need to call a hearing and so far, I've just checked out so look a few seconds ago but hearing has still not been called yet. But in the case that a hearing does not get called we will continue to try to find ways to support, and even organize on campus to, you know, implore legislative sessions in the future to continue to protect survivors on campus, as you know that's something that's really important and as you folks know recently there have been the whole kind of campus climate survey, that's been going around and so just wanting to continue to amplify and support that. But yeah, if you, if you have any particular questions about the legislative session or, you know, any suggestions and feel free to reach out to center kinds and or to myself and you can, you know, have conversations.

Vice President Kim Motion to accept Senate Resolution 03-21: In Support of the Amendment of the Uniform Parentage Act
Senator Chua Second.

Vote is unanimous. Motion passes.

Vice President Kim Hello. So, there are currently two bills in the legislature right now. Senate Bill 618, and House bill, I believe 1096. And what this what these bills would do is, in the way that it was submitted originally they both push for the change in the uniform parentage act to well, first, to change the language so that it's not explicitly gender in the binary manner. And the issue with that right now is that they defined parentage, and the concept of giving birth as a male or female thing. And the problem with that is that it assumes that couples with who are like couples by default include a heterosexual session there man the heterosexual woman. So in the case of couples who may be two men two women to non binary people, or any mix of that where it's not, it doesn't align by what is implied in the uniform parentage act, they would have to go through a very expensive and time intensive process where they would be declaring their parentage which they call paternity in the UPA. Although they could be married and have established that by all intents and purposes they are going to take care of this, like, child. And so, the most prominent portion would be that it would do that. And also it would make the state of Hawai'i recognize parental

determinations from other states and territories, including California which is a lot more lenient with how they define parentage, and the legal parents which they, I believe in California, it's not explicitly biological and it's based on like marriage, rather than being the person who provided the sperm or act as a gestational parent. And so, this bill would pretty much be saying that ASUH is supporting this bill in the legislature that we support the LGBTQ+ community, views the fight for LGBTQ+ civil rights as being far from over, and also argues that this conception of the family and it being intrinsically cis head man and cis head woman is not something, native to Hawai'i, and to reject different forms of families would be to view this Western like nuclear family as being the correct option which explicitly discriminates against LGBTQ families and people of different cultures whose family and this may not look the same.

And the reason why we're pushing for this is that there's about, I believe, two days until the bills have to be put into committee and 618 still hasn't been scheduled for hearing. And so by passing this bill we're hoping to send this out to activists, senators, and representatives who have introduced this bill to use this to push for a hearing to be heard and to pass this bill in the legislature in the future.

And then in the be it further resolve section, there's also calls for the university itself to be more aware and responsible when it comes to everyday language that may exclude LGBTQ+ equals like myself. Like still in all the forms I'm listed as male, I am not male non binary, they them pronouns. And so, going off on the spirit of this bill we would be calling on the university to actively review and replace language that may be outdated and that may exclude students whether it's intentional or not. And to implement LGBTQ + supported practices that in lieu of our current practices which we have yet to question, such as the male female gendering of the sports and sorry I'm very good with sports terminologies. But yeah, that and how we're approaching gender inclusive restaurants facilities which, as far as I'm aware, what's happening is that the departments who are requesting these gender neutral facilities and restaurants have to pay for it themselves rather than the university paying for them which I thought does not align with the claims that we've made in our BOR policy that states that we are an inclusive University.

President Albano

Thanks Vice President Kim. Honestly, this is incredible.

Vice President Kim

Well yeah, so I did use a lot of language that's well known among the LGBTQ+ community and like the Women's Studies Department sociology department, whatever and so if there's any language that might not be accessible for everyone just please let me know and we can make motions to make it more. Yeah, pretty much make it more accessible by including definitions. Thank you very much. Appreciate that.

Senator Renteria

If this is accepted, will it be sent out immediately, or like all the other resolutions, at the end of the year?

President Albano

Basically, um, so it would kind of still go through the process of, you know like, it'll get like codify it and all of those kinds of things when the upcoming minutes are approved but usually with like resolutions, once the senate adopts it then that kind of already becomes like our stance on it, it just like the publishing of the

resolution on the website. And I think also, depending on the timeline of it being sent out to the folks that are included in the now therefore being finally resolved then, like the sending out of it and maybe publishing on the website, will you know be once it's been codified, but the resolution, kind of, we already have, if we approve it then, you know, we are basically taking this stems from, I guess, and Advisor Manini please correct me if I'm wrong.

Hi. I have a question, Jungha, so you mentioned some of these terms are terms used by the Women's Center?

Vice President Kim

So these are just terms we use like LGBTQ community based discussions and stuff. And so it's just like, Because gender and sexuality is something that we're always aware of, because we're kind of living as being othered in reference to cis gender and heterosexual people system they're being people who identify as the gender and sex they were assigned with at birth. And heterosexual being you know straight. So, these are terms that the community uses and also the Women's Studies and like Queer Studies.

SAL Kaeo

Oh okay I understand. I think I misheard you.

Vice President Kim

Actually this is a question for Advisor Manini and I was wondering. So, it's just like a formatting thing, but I was wondering if we cited the exact same source for different whereas, would we have to cite it again or we just repeat the footnote number at the end.

Usually you guys just repeat the footnote. You don't recite the same thing again.
